



**MOJAN SKIN CARE CLIENT WAIVER AND RELEASE OF LIABILITY -
PLEASE READ CAREFULLY BEFORE SIGNING**

This Client Waiver and Release of Liability ("Agreement") is executed on this ____ day of _____, 20____, by and between Mojan Skin Care ("Company"), located in Houston/SugarLand, Texas, and the undersigned client ("Client"). By signing this Agreement, Client acknowledges and agrees to the following terms and conditions:

1. Voluntary Participation

Client acknowledges that participation in skin care services provided by the Company is voluntary. Client has been informed of the nature of the services and has had the opportunity to ask questions regarding the procedures and associated risks.

2. Description of Services

Company offers various skin care treatments, including but not limited to:

- Acne facials - Firm and lift facials - Back facials - Chemical peels - Enzyme treatments and more; these services are designed to improve skin appearance and health.

3. Acknowledgment of Risks

Client understands and acknowledges that skin care treatments involve inherent risks, which may include, but are not limited to:

- Redness - Swelling - Irritation - Allergic reactions - Hyperpigmentation - Scarring

Client agrees to inform the Company of any known allergies, skin conditions, or medical conditions prior to receiving treatment.

4. No Guarantees

Client acknowledges that the Company has made no guarantees regarding the outcome of any skin care treatment. Results may vary based on individual skin types, conditions, and adherence to post-treatment care instructions.

5. Medical Consultation

Client understands that skin care treatments are not a substitute for medical care. Client agrees to consult with a licensed healthcare provider for any medical concerns and to disclose any medical conditions or medications that may affect the outcome of the treatment.

6. Release of Liability

To the fullest extent permitted by law, Client hereby releases, waives, and discharges Company, its owners, employees, agents, and representatives from any and all claims, liabilities, damages, or causes of action arising out of or related to the services provided, including but not limited to claims of negligence, personal injury, or property damage.

7. Indemnification

Client agrees to indemnify and hold harmless Company, its owners, employees, agents, and representatives from any claims, damages, liabilities, costs, or expenses (including reasonable attorney's fees) arising out of or related to Client's breach of this Agreement or Client's negligent or wrongful acts or omissions.

8. Confidentiality

Client understands that personal information and treatment details will be kept confidential in accordance with Company's privacy policies and applicable laws.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas. Client agrees that they waive any right to bring legal action in any other jurisdiction and that any legal dispute shall be subject to the exclusive jurisdiction of arbitration in Harris County, Texas, as outlined in Section 11.

10. Severability

If any provision of this Agreement is found to be unenforceable or invalid, the remaining provisions shall remain in full force and effect.

11. Arbitration Clause

Client agrees that any disputes, claims, or controversies arising out of or related to the services provided, including those related to the validity, enforceability, or scope of this Agreement, shall be resolved exclusively through final and binding arbitration conducted in Harris County, Texas, in accordance with the rules of the American Arbitration Association. By signing this Agreement, Client waives any and all rights to a jury trial, class action, or to bring or participate in any lawsuit against the Company or its representatives.

12. Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes any prior discussions or agreements, whether oral or written, related to the subject matter herein.

13. Acknowledgment

Client acknowledges that they have read and fully understand this Agreement, have had the opportunity to ask questions, and voluntarily agree to its terms.
