- 2. The January minutes were read and approved unanimously
- Warrants presented for approval. Beth motioned to approve all warrants, Joel seconded and the motion carried unanimously.

Fire Fighter Reimbursement Rates 2020

Effective March 11, 2020, the Santa Margarita Fire Department has established the following policy regarding Fire Fighter Reimbursement Rates:

The Fire Chief and Board of Directors reviewed the Fire Fighter Reimbursement Rates and determined that an increase was necessary. The rates were determined by the State of California minimum wage and the Department budget.

The rates are as follows:

Recruit, no firefighter training:	\$10.00 hr.
Probationary Firefighter completed SLO Academy	\$11.00 hr.
Firefighter, Task book complete	\$12.00 hr.
Fire Apparatus Engineer/ Driver Operator	\$13.00 hr.
Line Officer	\$15.00 hr.
Training Officer	\$50.00 mo.

The Fire Board and Fire Chief will review this Policy annually for any necessary adjustments. Any adjustments must be approved by the Fire Board.
