Wedding Day Logistics

- On the wedding day, the bride must communicate the importance of being on time and properly prepared.
- Every person getting their hair done in an up-do, half-up style, or curls must have their hair already washed with shampoo ONLY and blown dry.
- If such a case arises where the hair is not dry, the stylist will charge extra to blow dry or the service will be forfeited and the charge will still apply.
- It is important for all participants receiving hair services to wear a button down shirt as to not damage the hairstyle that was just completed.
- The BRIDE must confirm and commit to the number of services stated above. Charges will include all people stated above.
- The stylist needs a designated space to set up when on location. The BRIDE needs to accommodate an appropriate work area before the stylist arrives. The stylist will need an area with a chair near an outlet and in a no walk-through traffic space. Good light and a mirror is a plus!
- If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply.
- The hair stylist will not be held liable for any injuries that should arise while on location.

Fee Details

Deposit: A deposit of 50% of the total services (excluding \$125+ for the bride)
Is due to hold the day, **this is non-refundable.**

TRAVEL: There is no charge within 15 miles of Tallahassee. Fees can be negotiated per event. Bride will be responsible for any parking fees that occur with event.

TRIAL RUN: A trial run is recommended for the bride. This needs to be booked at least 30 days prior to the wedding day Based on availability, the actual appointment can be up to 1 week before the wedding. The trial will take place in the salon. There is a fee of \$125+ (determined by the stylist) due on the day of the trial and that will cover the day of the wedding as well. If the stylist has to drive to the site of the wedding to perform services and the distance exceeds over 15 miles of Tallahassee, there will be an additional fee that is pre-determined by the stylist due at the time of the Bridal Trial Run.

Wedding Day

The bride agrees to pay in **full** the remainder of the total balance on the wedding date. The total amount due is based on the wedding day services requested. The total fee is due to the hair stylist as described, regardless of internal arrangements between the bride and the others receiving services. The payment can be cash, check, or charge.

BRIDE SERVICES: \$125+ FOR TRIAL RUN & DAY OF WEDDING (final price determined by stylist)

BRIDAL PARTY: \$75.00 (Up-do, Curls, or Half-up Style)

BlowDry/Style: \$50.00

CHILDREN: \$45.00 (12 & up) (Children younger than 12, prices to be discussed with stylist)

Please note: Prices may vary due to the length of hair.

One stylist will be guaranteed on the Wedding date unless other arrangements have been made prior. Upon receipt of this contract, the stylist will total the amount that is due on the wedding date as well as provide a detailed schedule to the bride. Please be advised that the Bride and other participants may be photographed and published on the company's website and other social media. No photos will be sold to any outside party. Should the stylist have a personal emergency that prevents her from performing services as agreed, all efforts will be made so that a replacement stylist will be present to perform the contracted services. Should an emergency occur so last minute that no stylist can be made available, all fees will be refunded.

This contract is due 30 days prior to the wedding date or the date will be released and made available on a **first come, first serve basis**.
