# Provide dedicated resources that meet the needs of those affected by Breast Cancer

A breast cancer diagnosis is very expensive, even with quality health insurance. For the underinsured or uninsured, a diagnosis can devastate the family. Mounting medical bills means many families are unable to afford important necessities, such as clothing, shoes, household items, personal care products, or baby and children's items.

The Becky Baker Foundation has partnered with <u>The United Breast Cancer Foundation</u> to help meet the needs of these families by creating the *Becky Baker Foundation Survivors Resource Center* where these families are able to select from hundreds of free items their families need, relieving some of the burden, fears, and financial constraints facing those battling breast cancer.




## **ABOUT US:**

The Becky Baker Foundation was formed in 2017 in honor of Becky Baker following her brave battle with Stage IV ER+ Metastatic Breast Cancer. Understanding the challenges and financial strain cancer has on those diagnosed and their families, Becky's husband formed the foundation to help others.

The initial commitment of the Becky Baker Foundation was to provide mammograms and thermograms as a form of prevention. At the time, access to those preventive measures was limited and very expensive. Within seven years, Rick and the Foundation gave away more than **3,000 mammograms and thermograms** to anyone who wanted one, no questions asked. The estimated value totaled \$650,000. Due to the increased availability of free screenings through insurance companies and Medicaid, the Foundation then turned their efforts toward additional preventive education and meeting the needs of cancer patients and their families. Rick Baker explains, "We have made thousands of people aware of breast cancer prevention methods, and we've done it year-round rather than just in October (Breast Cancer Awareness Month.) The Foundation has been GuideStar certified platinum with a gold star every year. We are very proud of that! More importantly, we are proud of the lives we've saved and the families we've helped all across Colorado."



# **Prevention through Education**



Based on his experience standing with his wife Becky when she was diagnosed with stage IV breast cancer, founder Rick Baker experienced the struggle involved in trying to help his wife battle a disease he knew little about. Recognizing that other men, and their loved ones, could benefit from his newfound knowledge, Rick wrote, "The Guy's Guide to Everything Breast Cancer." The book is a powerful tool designed to educate its readers on ways to prevent breast cancer or, if already present, how to provide meaningful and powerful support that their family member needs to fight this evil disease. Public and grants funds are used to make free copies of this important resource available to families across the nation.

<u>AWARENESS</u> Heightened awareness through BBF special events and free resources regarding the impact of nutrition, stress, environment, and relationships, and the changes possible to help prevent a breast cancer diagnosis. **EDUCATION** Since publication in 2021, over **5,000** copies of "A Guy's Guide to Everything Breast Cancer" by BBF's founder has reached readers through distribution at hospitals, breast care centers, and the BBF Survivor Resource Center, educating and equipping them to win the breast cancer battle. Additionally, support group discussions for patients, survivors, and their family members are provided to educate and empower all participants.



<u>PREVENTION</u>Since formation in 2019, the BBF has funded 3,000 mammograms and thermograms as a preventive measure, with an estimated value of \$650,000 Through the BBF's *Peer & Partner Prevention Program*, speaking engagements, community events, collaterals, and a robust social media campaign are utilized to promote prevention as well.



SUPPORT To date, over \$4.2 million dollars in merchandise has been given to breast cancer patients, survivors, and their families. From clothes, health and beauty aids, and household items, these free resources through the BBF Survivor Resource Center provide financial relief for those battling breast cancer, allowing them to meet the needs of their families while paying exorbitant medical hills
