The undersigned agrees to the following Terms and Conditions:

1. Exhibitor must be **in place by 9:30am** and remain in place all hours of the show, positively no early packing. This show is Rain or Shine. If you don't show, we will not refund your money. **There is no rain date.**

2. Exhibitor shall not assign or sublet all or any part of said space.

3. Space is to be used for the selling of products or services. Family friendly exhibits only. Management reserves the right to remove any items they deem not appropriate to the show.

4. Exhibitor agrees to abide by all municipal, state and federal laws in connection to the sale of items. It is your responsibility to collect appropriate taxes and submit them accordingly.

5. FOOD VENDORS: Must obtain a Mobile Food Vendor / Peddlers Permit from the Village of Canajoharie. If you need one with your application let me know and I will email it to you. Any food truck **using a fryer** will be inspected the morning of the event by code officer, VIllage of Canajoharie. There is a **\$10 fee** for one day payable to the Village of Canajoharie. **IMPORTANT:** If you have been given a time to set up and miss it you will be placed wherever is convenient to not disturb the rest of the set up vendors. **NO EXCEPTIONS**

6. Exhibitor agrees to pay for any damage to grounds, tents or goods caused by him or herself or any of their employees and helpers.

7. By acceptance of this agreement, the exhibitor expressly releases all sponsors, their employees and helpers, of and from any loss to any person or goods for any reason whatsoever, including but not limited to tent and weather related problems. In the event that the show cannot take place all monies will be refunded in full. Show organizers are not responsible for the damage or loss of property due to fire, theft, breakage, inclement weather or any other cause whatsoever. A separate hold harmless agreement is required to be signed upon your arrival for set up. Refusal of signing will constitute a breach of contract and you will not be allowed to set up with no refund of payment..

8. Exhibitor agrees to leave their space in good order with no trash or debris left behind.

9. All vehicles must be parked in our exhibitor parking areas. No driving on the exhibition areas during show hours. No working out of vehicles. A single space is considered 12 feet x 12 feet. Multiple spots may be purchased. (See contract) **Tents/pop ups, chairs etc are your responsibility & must be secured properly to prevent wind damage. The Street Fair is not responsible for damage to your property.**

10. Exhibitor cancellations must be received before August 31, 2025 to have all but \$20.00 returned, booth fee is otherwise forfeited. There are **no refunds for no shows or cancellations** after **August 31**, 2025.

11. **ELECTRICITY**: If you require power you must provide your own generator. **ALL GENERATORS MUST BE QUIET**. No construction generators will be permitted.
