SunScreen Policy Updated June 2020

Child Safety is our first priority. Living in Florida means exposure to heat and the sun. Below is the Foundations Policy regarding Sunscreen:

- 1. When sending your child to school, be sure they are lathered up with a sunscreen that has a minimum SPF of 30 and that you provide your child's teacher with additional labeled sunscreen to keep in the classroom.
- 2. For **children 3 and under**, the Teachers will apply the sunscreen. The sunscreen will be applied when there are at least two staff members present and only if there is written permission by the parent to do so.
- 3. The children in our **4s class and summer camp** will be applying sunscreen themselves under the guidance of a staff member. If a child in this group needs assistance in applying the lotion, at least two staff members must be present and written permission must be provided.
- 4. All water play (if we are able to have waterplay this year) will take place in the morning when the power of the sunscreen is most affective.
- 5. Afternoon play will be restricted to the shaded playground.
- 6. A daily check of the heat index will be done to ensure outside play is appropriate.
