### GUIDELINES FOR PARTICIPATION IN SOUTHWESTERN TRAVIS COUNTY GROUNDWATER CONSERVATION DISTRICT BOARD MEETING on July 8<sup>th</sup>, 2020

Southwestern Travis County Groundwater Conservation District, in order to maintain governmental transparency and continued government operation while reducing face-to-face contact for government open meetings, is implementing measures according to guidelines set forth by the Office of the Texas Governor, Greg Abbott. In accordance with section 418.016 of the Texas Government Code, Governor Abbott has suspended various openmeetings provisions that require government officials and members of the public to be physically present at a specified meeting location. SWTCGCD's adherence to the Governor's guidance temporary suspension procedure provides public accessibility and opportunity to participate in our open meetings, workshops, and hearings.

Members of the public wishing to make comments during the meeting will be provided an opportunity to do so. The Board President will call on members of the public who wish to speak during the public comment period of the meeting or during the discussion of specific agenda items. Members of the public that wish to speak during the meeting are requested to notify Kodi Sawin (generalmanager@swtcgcd.org) by noon on Tuesday, July 7<sup>th</sup> to help facilitate the meeting logistics. This meeting will be recorded, and the audio recording will be available upon request to Ms. Sawin after the meeting.
