



**Notice of Open Meeting of the Board of Directors**

**Roy Creek Canyon Reserve**

Notice is hereby given that representatives from the SWTCGCD Board of Directors are meeting for an educational tour of Roy Creek Canyon Reserve (the "Premises"). A quorum of the Board of Directors may be present during this meeting; however, no formal actions or votes will be taken by the Directors.

Members of the public that wish to attend should notify SWTCGCD General Manager Lane Cockrell ([generalmanager@swtcgcd.org](mailto:generalmanager@swtcgcd.org)) by noon on Wednesday, November 9th to help facilitate meeting logistics.

The tour is scheduled to begin at 10:00 a.m. at the property entrance gate (located on Hamilton Pool Road between Hamilton Pool Preserve and the Pedernales River crossing; see directions below for additional information) and will take approximately two hours.

Participants should be prepared for a short hike and climb, potential inclement weather, spotty cellular service/signal, and are responsible for bringing their own food and water.

**DIRECTIONS**

From Hwy 71 in Bee Cave, or RR 12 in Dripping Springs, take Hamilton Pool Road to the Hamilton Pool Preserve. Continue approximately one-quarter mile past Hamilton Pool Preserve to the "Norsworthy Ranch" gate on the left. If you reach the Pedernales River, you have gone too far. Participants should meet at the "Norsworthy Ranch" gate and will be admitted at 10:00 a.m. (or shortly after) to drive in as a single group.

**GUEST AGREEMENT TO WAIVE AND RELEASE LIABILITY**

Guest acknowledges that Owner has made no warranties, representations, or guarantees of the safety or condition of the premises, facilities, and services at the Premises.

**WAIVER AND RELEASE OF LIABILITY.** Upon entry to the Premises, Guest WAIVES AND RELEASES any and all claims of liability against the Owner, agrees not to sue or institute any legal proceedings against the Owner, and agrees to hold harmless the Owner, with regard to and in connection with any and all damages, claims, demands, rights, and causes of action of any kind or nature based upon injuries, property damage, or death suffered by a Guest arising out of or in connection with the use, enjoyment, or occupancy of the Premises, INCLUDING ANY CLAIMS ARISING OUT OF THE NEGLIGENCE OF OWNER, IN WHOLE OR IN PART.

**RULES AND AGREEMENT TO VACATE PREMISES.** Guest agrees to abide by all rules and regulations established by Owner regarding the use of the Premises, including but not limited to such rules as may be verbally communicated, posted on signs, or otherwise communicated to Guest. Guest agrees to leave Premises upon expiration of any period of admission, or immediately upon the request of Owner for any reason.
