**BIO:**

**Naomi Akers, MPH**, is a Bay Area native and has worked as a sex workers' rights and harm reduction advocate in the San Francisco Bay Area since the early 1990s. Ms. Akers started her activism in the early days of HIV/AIDS advocacy in the early 90s in San Francisco. She received her undergraduate degree in Women's Studies from San Francisco State University (SFSU). She then spent several years working in the Domestic Violence field as a counselor. After witnessing the denial of sex workers with violent partners into the shelters because their partners were labeled "pimps", Ms. Akers joined several others from the DV community to work with PROMISE for 5 years, a sex worker outreach program and drop-in center in the Civic Center. In 2002, Ms. Akers began working as a research associate in the field of HIV and Hepatitis for the Urban Health Study. She has also worked as a research associate for several prominent studies including the HOPE study, the SWEAT study, and the St. UFO study. In August 2006, she became the Executive Director for the St. James Infirmary (SJI), a free medical clinic for sex workers where she had worked since 2002 and has been a client since 1999. In 2008 she returned to SFSU, where she earned her Master in Public Health (MPH) degree. Ms. Akers' areas of interest center around harm reduction approaches, social justice and health as a human right, particularly for sex workers, and drug users. As part of her MPH studies and as a project for Legal Services for Prisoners with children, Ms. Akers conducted an oral health assessment of pregnant prisoners at Valley State Prison for Women in Chowchilla, California. This project contributed to the dismantling of the Department of Corrections oral health clearance requirements that prohibited women prisoners from entering community-based programs to live with their children. In the summer of 2006, she completed an internship project assessing SF Exotic Dancers health needs. Ms. Akers has served as a member of the SF HIV Research & Vaccine Trials Network Community Advisory Group for 4 years and as a member of the UNAIDS Sex Worker Global Working Group for two years. Beginning in 2010, Ms. Akers has worked on a nightlife safety study and training intervention to promote safe and fun nightclub environments for all patrons and club staff in San Francisco. She was appointed by the Board of Supervisors to the San Francisco Entertainment Commission in 2012 where she served for two years in the public health seat. Ms. Akers has been "sainted" by the Sisters of Perpetual Indulgence for her commitment to community service. In 2013 Ms. Akers transitioned out of her position of Executive Director for the St. James Infirmary and became a member of the Board of Directors where she served for four years. Ms. Akers, aka "Saint Ho's Up" is currently working as an advocate on statewide policy work on behalf of the larger sex worker community. Ms. Akers' mother is a medical writer and her father was a printmaker and painter in the East Bay, member of the lithographer's union, and he once painted legendary sex workers rights activist and St. James Infirmary namesake, Margot St. James. Following in her fathers' footsteps, in 2013, Ms. Akers moved back to the East Bay, where she worked as an artist, medical writer and animal trainer until the "plague". Since September, 2021, Ms. Akers works at WORLD in Oakland, California as the Outreach Coordinator and Specialist for a COVID 19 Vaccine Ambassador program.
