## **Judge Kevin W. Dunn Elected to Executive Committee of the Ohio Association of Probate Judges**



MEDINA – Medina County Probate Judge Kevin W. Dunn was sworn in via Zoom by Ohio Supreme Court Chief Justice Maureen O’Connor to the Executive Committee of the Ohio Association of Probate Judges June 8.

Judge Dunn was nominated and subsequently elected by fellow members of the Ohio Association of Probate Judges to serve as Secretary and Historian to the Executive Committee. His duties will include maintaining meeting minutes and ensuring all documentation is in order.

The Ohio Association of Probate Judges is comprised of judges in Ohio with probate court jurisdiction. The Association operates for educational and charitable purposes, and allows the sharing of ideas and experiences concerning the operation of probate courts. Judge Dunn has been a member of the Association since 2013.

The purpose of the Executive Committee is to serve as a united voice for Ohio probate judges to follow statutory and legislative changes and present testimony and evidence to legislative bodies.

“It is an honor to be nominated and elected for a position on the Executive Committee where I can serve as a member of the consolidated voice for Probate Judges throughout the State of Ohio,” Judge Dunn said. “I look forward to continuing my duties to make a positive impact for not only Medina County, but state-wide.”

The Honorable Kevin W. Dunn has been presiding over the Medina County Court of Common Pleas Probate and Juvenile Divisions since August 2013 upon being appointed by Governor John Kasich. Judge Dunn was elected by Medina County voters to continue his duties in the position in February 2015 and elected for an additional six-year term in 2021.
