Judge Kevin W. Dunn is one of the four judges of the Common Pleas Court. He began his tenure on the Bench on August 5, 2013. Judge Dunn's elected six-year term began February, 2015.

The Medina County Probate and Juvenile Courts, wherein Judge Dunn presides, has jurisdiction over all cases involving persons under age 18. These cases are categorized as delinquent; traffic; unruly; and abused, neglected and dependent children. Probate matters, include but are not limited to estates, guardianships, and trusts.

Community Service: Youth performed more than 4,132 hours of service.

Parent Project: 27 families participated in this program.

Juvenile Court Offers New Ti-180 Program

The Medina County Juvenile Court began a new diversion program for eligible juvenile offenders. Teen Intervention-180 (Ti-180) is a program for first time offenders who receive an alcohol or other drug related charge.

During the 3 1/2 hour course facilitated by a licensed clinician from Solutions Behavioral Healthcare, Inc., the youth and at least one parent or guardian are provided education on early intervention for substance abuse and learn to identify the warning signs.



Probation Department

Probation officers investigate all aspects of the Juvenile's case and make recommendations to the Court to protect public safety and to achieve permanent improvement in a child's behavior. In 2015, 126 youth were placed on probation.

Court Collections

Court costs assessed by the Juvenile Court are distributed to state, county and local governments. The COPPER (Costs of Probation and Programming Expense Reimbursement) program was created to recoup part of the cost of court services.

Court Receives Tech Grant Funds for Improvements and Upgrades

The Court continues make to improvements and utilize current technology. Progress has been made thanks in part to grants awarded from the Supreme Court of Ohio Technology Grant Fund. The Technology Grant funds were used to purchase new digital audio recording equipment software upgrades. We were also able to purchase a Storage Area Network (SAN) device, allowing the Court to save digital images, and digital audio recordings. Supreme Court grants totaled approximately \$31,000.
