MISSION STATEMENT

The Medina County Juvenile Drug Court is an alternative for juveniles and their families whose criminal justice involvement stems from alcohol or drugs. Using community resources, the Program provides monitoring, intervention, treatment and structure to juveniles. The Program reduces recidivism, protects the community and shows juveniles how to lead a healthy lifestyle.

OVERVIEW

Medina County Juvenile Drug Court

- Supervises juveniles to ensure accountability and public safety
- Provides individual, group, home-based, equine-assisted, and mental health treatment
- Teaches families effective problem solving and parenting skills
- Works with schools to monitor attendance, and improve academics and behavior.

The Juvenile is charged with an alcohol or other drug related offense or tests positive



The Juvenile meets the eligibility criteria:


County resident; age 13-17.5; no history of violence, sex offenses or drug trafficking



The Juvenile and his/her parent(s)/guardians agree to participate in Drug Court and to complete a dual diagnostic assessment (substance abuse and mental health)



The Juvenile is ordered to complete either the Intensive or Non-Intensive Component of Drug Court



INTENSIVE COMPONENT


(Average 1 year)

Family participation is required. Placed on probation and ordered community service. Random drug screens. Mental Health services. Home-based intervention. Equine Programming as recommended.

NON-INTENSIVE COMPONENT

(Average 4 months)

Family participation is required. Placed on probation and ordered community service. Random drug screens.



Phase 1

2 groups per week, individual as needed & Court appearance once a week

Phase 2

1 group per week, individual as needed & Court appearance once or twice a month

Phase 3

Group and individual as needed & Court appearance as needed



Group counseling 1 day per week

Court appearance 2 times or as needed
