FIRST ORDER: CONFIRM MEETING MINUTES OF THE BOARD OF DIRECTORS HELD

ON MAY 28th 2020.

After Discussion Mr. Goodman made a motion to accept the May 28th 2020 Meeting Minutes with corrections, Mrs. Gilmer seconded the motion which passed unanimously.

SECOND ORDER: RECEIVE COMMENTS FROM THE PUBLIC.

Mrs. Judge questioned The Public information request regarding each employee's monthly salary and the General Managers spending limits.

Mr. Radich explained the requirements of the P.I.A. and advised how to resubmit the request. Mr. Radich also advised The Board to add an agenda item to discuss a policy for spending limits.

Mrs. Goodman commented on Mrs. Judges issues with Public Information Request and a Homeowners issue with drainage.

THIRD ORDER: DISCUSS CULVERT VARIANCES.

Mr. Radich explained the current application, requirements and responsibility for a culvert variance, and recommended that the policy be updated.
