



² Samples mounted for PLM analysis and not analyzed due to cancellation will be charged \$4 / mount. For ash testing, provide no more than 1 teaspoon, result is positive / negative.

³ Samples are subject to a Waste Management fee of \$2.50/ inter-island and foreign soil sample.

⁴ TCLP 24 hrs dropped on Friday are subject to a \$50 flat fee (for up to 5 samples), 6 hrs TAT only works for sample dropped in the afternoon.

⁵ For 24 hours TAT, results will be due at end of business day the following day.
