**INITIATION FEE:** \$100.00 (Family and Single) \$30.00 (Youth)

**DUES:** Payable annually. Includes monthly potluck fee.

- \$55.00 per year for youth single membership 18 to 21 years (all members under 18 must be included in family membership)
- \$100.00 per year for single membership 21 years or older
- \$150.00 per year for family membership (includes all children to age 18)

Dues are pro-rated after June 1, the Club calendar year, as follows:

Family membership \$12.50 per month  
Single membership (21 years or older) \$8.34 per month  
Single membership, under 21, \$4.59 per month

New members are on probation for 6 months from date of acceptance and are temporary members with rights and duties participation, but without voting rights. Their permanent membership will be determined by the quality and quantity of participation in WSC activities. WSC's desire is to have active and positively involved members who want to be a part of a strong saddle club actively promoting multi-facets of equestrian and personal activities. Club facilities are for club activities; they are not for individual member(s) business use or personal monetary gain. In the event the probationary member is not accepted for permanent membership, only the pro-rated portion of their dues, not the initiation fee, will be refunded.

After 6 months, temporary members shall be accepted or rejected as permanent members, per the Corporate Articles, By-laws and Resolutions. Voting rights will not be granted earlier than two years thereafter, and then only at the Board's discretion per the Corporate guidelines.
