3. RELEASE, DISCHARGE AND PROMISE NOT TO SUE W.S.C. OFFICERS, EMPLOYEES AND AGENTS (HEREINAFTER THE "Releasees"), for any loss, liability, damages, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property.

The undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk, is governed by the State of Arizona and is intended to be as broad and inclusive as is permitted by Arizona Law and, that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
