GENERAL DISCRIPTION: Administer, score, and interpret psychological tests of children, adolescents and adults. Provided neuro-psychological assessments as needed, to differentiate accurate diagnosis in order to better treat and serve patients. Provide assessment, diagnosis and psychotherapy utilizing a range of therapeutic techniques, to include culturally appropriate, trauma informed treatment modalities to meet the needs of children, juveniles, adults and the elderly. Provide therapy services within the school-based behavioral health for children and adolescents, including via telehealth. Provide training for other behavioral health staff, medical staff, law enforcement, first responders, and community programs, as requested. Collaborate with primary care providers/other health professionals in order to develop accurate treatment plans for medical and behavioral health conditions. Participate in quality improvement activities, audits, chart reviews and plans for improving performance of the Integrated Behavioral Health Program overall. Participate in program development for overall quality improvement of the program, including researching and implementing best practices in behavioral health services provided. Provide indirect/direct case management and patient care support within the community. Provide crisis management of patients, to include afterhours 24/7 on-call consultation services to assess suicide severity in identified patients. Serve as a representative and liaison for Integrated Behavioral Health Tribal Administration, Tribal Council, and with other Tribal Health and Tribal Programs and Services as indicated.

DUTIES AND RESPONSIBILITIES:

- Complete intake assessments and interpretations based on biopsychosocial evaluations, psychometric tests, structured clinical interviews, therapy sessions and neuropsychological assessments.
- Provide treatment for a wide range of psychological and behavioral health disorders using a variety of therapy modalities.
- Provide individual, group and family psychotherapy on an acute and situation specific basis, utilizing a broad range of treatment techniques.
- Provide evaluation and initial treatment in complex cases involving the probability of mental illness, neuropsychological and behavioral aspects of chronic disease, developmental disability, and substance use/abuse disorders.
- Recognize and address psychological symptoms and conditions using the bio-psychosocial model.
- Provide effective triage of persons in need of referral to higher levels of behavioral health care as appropriate.

- Provide psychological evaluations, crisis intervention, and suicide severity assessments in complex cases involving the probability of mental illness, neuro-psychological conditions, chronic disease, developmental disability, and substance use disorders.
- Collaborate with other healthcare providers to evaluate medical and physical condition of patients.
- Formulate and create individualized interventions, treatment and management plans for patients.
- Assess patient's potential risk to self/others or property, when determining mental health and social needs, while performing interventions.
- Interact with patients and other parties regarding performing interventions in culturally appropriate, trauma informed approaches.
- Employ various treatment methods such as psychotherapy, hypnosis, behavior modification, stress reduction therapy, mindfulness, or cognitive therapy, which best serve client process and outcome needs.
- Measure effectiveness of interventions and implement changes where required.
- Ensure the maintenance and safe storage of accurate program and client records, and all other pertinent documents.
- Maintain confidentiality of patients' treatment and records in accordance with HIPAA. Participate
 in the clinical training seminars and mentoring of psychologists, psychology students and interns
 on site.
- Work towards positioning the agency as a pioneer in cross cultural psychological interventions.

EDUCATION:

Doctoral degree in Clinical Psychology (Psy.D. or Ph.D.)

REQUIREMENTS:

- One year post-doctoral supervised experience, and passing the EPPP (Examination for Professional Practice in Psychology) are required at a minimum.
- Experience with specialized psychological assessment and treatment of a wide range of mental health problems of varying severity and complexity.
- Proficient with psychological therapies, risk assessment, training and supervision.
- Proficient with planning and performing psychological interventions.
- Awareness of current developments in the area of Psychological Knowledge and practice.
- Ability to maintain and complete clinical documentation consistently in a timely manner.
- Must undergo a pre-employment back ground check and must be credentialed.
- Must be currently billable as a licensed provider.
- A current, active, valid and unrestricted clinical license to practice Psychology independently from a U.S. State, the District of Columbia, Commonwealth, territory or jurisdiction is required.
- Must have knowledge of medical and psychopharmacologic sciences leading to eligibility for licensure as an independent psychological practitioner with prescriptive authority (Post-Doctoral Masters of Science in Clinical Psychopharmacology or its equivalent, from an accredited institution of higher education).

SPECIAL CONDITIONS:

- Must have access to phone service and internet.
- Must have experience in performing telehealth services.
- Performance of duties require during and after-hours business hours.

- Willing to work on weekends and holidays for 24/7 on-call crisis situations.
- Incumbent must never have been convicted of a felony, will subject to, and must comply with the Fort Belknap Community Council Substance Abuse Prevention-Drug/Alcohol free and Drug and Alcohol Testing Policy.
- Incumbent must submit to a background check, which includes criminal history and work history.
- Indian/Veteran Preference Policy Applicable.
