Once the Petitioner(s) file, there will be a public notice posted for 3 consecutive

weeks. Once the 3 weeks is up, the clerk will set the time and place for the

hearing.

Petition:

The Court will keep the original documents and will give the Petitioner(s) and

Respondent(s) copies of everything that is filed.

Filing Fee:

Elders (55+) do not have to pay any fees.

The cost of filing this petition is \$25.00. You may apply for a fee waiver but must still pay \$10 for the cost of service. The Fee Waiver Application can be turned in with the petition and the judge determines if you qualify. The \$10.00 is required

for all petitions.

Note: The Court will not accept the Petition until the Petition is complete. Meaning, all of the

documents and information needed are produced and fees are paid.
