

## Madyson Hope Photography Contract

This agreement is between Madyson Hope Photography and \_\_\_\_\_ (CLIENT).

1. Scope of Work: This contract is for services and products related to a photography shoot at the following time and place. MADYSON HOPE PHOTOGRAPHY and CLIENT are to arrive for the shoot at \_\_\_\_\_ (TIME) at \_\_\_\_\_ (PLACE). MADYSON HOPE PHOTOGRAPHY agrees to provide no fewer than \_\_\_\_\_ photos for CLIENT due to the PACKAGE \_\_\_\_\_ chosen to have after the shoot, and is not required to provide more than this number of images. MADYSON HOPE PHOTOGRAPHY will perform basic post-processing or digital image editing services on these photos, where artistically necessary.
2. Fees: In consideration for the photography services provided by MADYSON HOPE PHOTOGRAPHY, CLIENT agrees to pay the sum of \_\_\_\_\_. CLIENT agrees to pay the photographer a non-refundable initial payment/deposit totaling 50% of the total price of the

photography services upon signing this contract/booking the photoshoot date. The initial payment reserves the photographer's time and is a deposit. MADYSON HOPE PHOTOGRAPHY agrees not to advertise the availability of this same time slot to any other potential clients. If the CLIENT cancels for any reason 7 days before the photoshoot date, the initial payment/deposit will not be refunded to the CLIENT. The balance of the payment for photography services must be paid in full no later than 7 days before the SHOOT detailed in Section 1: Scope of Work. Prices may change without notice at any time. The CLIENT will be charged 10% in every transaction for a traveling fee. If the photoshoot location is under 30 minutes from MADYSON HOPE PHOTOGRAPHY, the CLIENT will be refunded the traveling fee.

3. Payment: Cashapp, Venmo, Zelle, Cash, Check, and Tap to pay are all accepted for payment of MADYSON HOPE PHOTOGRAPHY services. If CLIENT is choosing to pay by Tap to pay, they must pay the full amount listed and agreed on in Section 2: Fees minus the 50% deposit before the photoshoot begins.

4. Work Product: MADYSON HOPE PHOTOGRAPHY will deliver all photos to the CLIENT no more than 14 days after the shoot date. CLIENT understands and agrees that photos are the exclusive property of PHOTOGRAPHER and CLIENT has no right to these photos except for a license to review them, but not store the proofs. All photos delivered to the CLIENT are licensed for the CLIENT's personal use only. MADYSON HOPE PHOTOGRAPHY will strive to present photos in a work-like manner, but is not required to cater to the specific aesthetic preferences of the CLIENT.

5. Duty of Client: CLIENT will obtain all permissions necessary for MADYSON HOPE PHOTOGRAPHY to photograph at the SHOOT. MADYSON HOPE PHOTOGRAPHY has no duty to obtain permission from reception centers, churches, buildings, properties, or other locations to operate thereon. CLIENT understands and agrees that any failure to obtain these permissions resulting in fines to MADYSON HOPE PHOTOGRAPHY, or which prevent the photographer from photographing the event(s), is not the fault, liability, or responsibility of the photographer. CLIENT must send the contract back to MADYSON HOPE PHOTOGRAPHY 14 days

before the shoot date to confirm the booking, and will be sent an email receipt of appointment details and a copy of the signed and completed contract. If CLIENT does not respond within 14 days of the shoot date, their booking will be canceled.

6. Exclusive Photographer: CLIENT agrees and understands that no other party other than MADYSON HOPE PHOTOGRAPHY may take pictures of any poses, lighting situations, or setups made by the photographer. This slows down the photographer's work and violates the photographer's right to take pictures of the event. CLIENT agrees to take responsibility for insisting that no person(s) get in the way of the PHOTOGRAPHER or take pictures in these situations.
7. Model Release: CLIENT grants permission to PHOTOGRAPHER and its assigns, licensees, and sublicensees permission to use CLIENT'S image or likeness in any form of media for commercial purposes, advertising, trade, personal use, or any other uses. Therefore, MADYSON HOPE PHOTOGRAPHY may use the CLIENT'S

likeness and image on MADYSON HOPE PHOTOGRAPHY's website or other advertising.

8. Assignability and Parties of Interest: CLIENT agrees and understands that, unless otherwise specified in this Contract, CLIENT is not contracting for a personal service that will be performed by any specific photographer. There's a 10-minute buffer window. If after 10 minutes and there's a no-show on the CLIENT's part without communication, MADYSON HOPE PHOTOGRAPHY will leave the designated location, and a refund will not be granted. If the CLIENT communicates that they will be late to the shoot, but no later than 10 minutes, everything within this document stands.
