

The Meeker Industrial Authority is committed to fulfilling the requirements of the PRO Housing Grant. The Trustees are residents of the Town of Meeker, living within a seven-mile radius of the town, and/or own and operate a business in the Town. Tracey Deveraux is serving a one-year term and has over 28 years of experience as an insurance adjuster. Anthony Buoy is serving a term of two-years and has owned and operated businesses in Meeker. Josh Sims is serving a term of two years and has over 15 years of banking experience. Donna Weber is serving a three-year term and is currently the Mayor and Trustor. Leslie Wilbourn is serving a term of three years, has over 25 years of project management experience, and is the Grant Administrator for the Town of Meeker. Each of the Trustees will be eligible to continue to serve with a succession for a term of three years, respectively. In the event of a vacancy in any trusteeship, the Trustees for the Meeker Industrial Authority will make recommendations to the Meeker To yn Board, which will officially approve the recommended Trustee. 
