PHOTO BOOTH RENTAL SERVICE AGREEMENT

SERVICE

The service provider will arrive approximately 30-60 minutes prior to your requested start date on the date of your rental. If the Client would like the Provider to arrive earlier, the Client will be charged at our current hourly "non-operational" rate of \$ 50 per hour. Provider agrees to have a photo booth operational for most of the booking time if there are people wanting to use the service. Occasionally, operations may need to be interrupted for maintenance of the Photo Booth (changing photo paper, adjusting the camera, adjusting printer, lighting, etc., when applicable.) to achieve a quality product. Payment for any overage in time must be paid before additional hours will be provided. If the Event ends earlier than expected, no refund will be given. If, for any unforeseen reason, we are unable to arrive until your event begins or need to arrive early/late, we will notify you as soon as we know. If for any reason on our part (including but not limited to equipment malfunction), we are unable to start your event at the agreed-upon time or continue your event, we will compensate you for any lost service time first by providing additional time if the venue permits. If the venue does not permit it, then we will refund you for just the prorated amount of the hourly fee lost. No compensation shall be made for delay caused by the client once the staff has arrived at the event location noted on the contract, whether due to incorrect address, insufficient power, unclear instructions, or otherwise. Please note that the last photo booth session must end 10 minutes before the service end time.

Access, Space, and Power for the Photo Booth

Payments

Prices are subject to change – please check for current rates before booking. By paying any part of the invoice, the hirer is also agreeing to the terms and conditions. The outstanding amount must be paid by the hirer to Glam Shots Photo Booth, 360, at least 48 hours before the event. If booked within seven days of the event, it is non-refundable; full payment must be received within 48 hours of booking. A travel surcharge may apply to events outside of the 50-mile radius of Jacksonville, Florida. An idle fee may apply for an extensive waiting period. Specific dates may be subject to an additional surcharge. Fancy dress props (If Used) Must be in good order at the end of the event; otherwise, a charge may apply.

Cancellations

If the hirer cancels within seven days of booking, the deposit will be returned in full. Prior notice is required of changes to the time and date of the event. Photo booth events cannot be held responsible for unforeseen delays at the venue.

Service pricing: The pricing differs depending on how many hours it is rented. See the attached brochure for prices and services. Booking: A minimum booking of two hours is required. Your desired date and services will be secured when the deposit payment and signed contract are received. Set-up Requirements: A floor space of at least 10 x 10 with a minimum ceiling clearance of 8 feet is required to accommodate the photo booth. A three-pronged Standard electrical outlet from a reliable power source at least 15 feet away is also required. The client is responsible for any damage calls to our equipment and or attendance due to improper power provision. For outdoor events, we must be in a totally dry spot, on a paved or grassy surface, free of dirt, and protected from wind, cold, heat, or direct sunlight.
