

Jackson Claim Jumpers (JCJ's) covid protocols, procedures, and recommendations:

You must sign upon your entrance at the Amador Senior Center a mandatory Waiver concerning Covid Protocols. The Waivers are located at the front counter as you enter the Amador Senior Center. Please we urge each individual to read the Waiver thoroughly and if agreed to the Waiver, sign it. If any dancers who are planning to dance with the JCJs at the Amador Senior Center choose not to sign the Waiver, then they will not be able to square dance with us, or for that matter enter the Amador Senior Center. That choice falls to each individual personally.

JCJ's club protocol making hand-sanitizers available in different locations throughout the dance floor, use of which is strongly recommended, as well as hand washing in between dance tips. The JCJ square dance club also strongly recommends that if any dancer that is not feeling well and / or are having a fever or other symptoms to please stay home, and if necessary, please contact their physician or health care provider. If any dancer who has or will attend our dances discovers they are infected with Covid, they must notify the club immediately.

These recommendations have always been at the core of our club's safety to avoid spreading illnesses to fellow dancers. We frequently remind ALL dancers to please follow these club protocols. Club members and dancers have always been very compliant and aware of the club's health & safety illness rules. As far as the covid situation, our club does not require masks, but at the same time we do honor the personnel choice of our dancers to wear a mask or gloves if they wish.

We would really enjoy your company once again dancing with us and want you and all our dancers to be safe according to their personal and individual choices and decisions. Whether or not we are dancing and having FUN now, or those dancers who chose to wait for a latter date because of covid concerns, the JCJ club fully understands and respects every individual's decision. We also want to be clear that if at anytime covid concerns require shutdowns at the Amador County or Amador Senior Center level, then the JCJ's Board is united and will follow protocol and temporarily end ALL dancing immediately. We hope that our club protocols are understood, and we are looking forward to seeing you in a square soon. - * I **do not** believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- * I **have not** been diagnosed with Coronavirus/Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- * I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.
