A **non-refundable deposit** of **\$500** is due per mare upon arrival at SES. This deposit will be applied to all fees associated with the mare's care, board, and foaling services. Any deposit amount remaining after the mare is ready to be discharged will be applied as a credit to Owner's account at SES.

Southern Equine Services (SES) agrees to provide foaling services for the listed mare subject to the following terms and conditions:

- 1. SES agrees to furnish all of the facilities for the care and feeding of the mare while in its custody. A Foal Alert system will be used to monitor the mare as she reaches the final stages of her gestation in preparation to foal. A fee of **\$475.00** will be charged for use of the transmitting device. Mare Owner agrees to pay for care and feed at the daily rate of \$30.00 per day for foaling/nursing mares. All foaling/nursing mares must be on stall board. These fees are subject to change at the discretion of Southern Equine Services.
- 2. SES will exercise judgement in the care and supervision of mare and foal. SES veterinarians will administer medical care as deemed necessary for the health and safety of the mare and foal at Mare Owner's expense.
- 3. Mare Owner understands that SES is NOT a 24 hour staffed facility. SES doctors and staff will respond to foal alert as quickly as possible.
- 4. Mare Owner understands that mare may or may not produce a healthy or live foal regardless of assisted reproductive technology employed by SES. SES will diligently try to produce a live and healthy foal, but if they are not able to, SES shall be held harmless. Mare Owner is aware of the inherent risks involved with reproductive and foaling procedures and understands the risks involved with the mare and the foal.
- 5. Mare Owner agrees to be responsible for payment of all services rendered, which includes all board and care expenses and all treatments/medications utilized to assist mare with foaling and care of the foal. All charges and expenses must be paid in full before the mare and foal will be released from SES regardless of final outcome.
