#### 2024 Stallion Shipping Terms & Conditions - Please sign and return to Southern Equine Services

No semen can be shipped until the entire completed form is on file at Southern Equine Services.

**Stallion collection days are Monday, Wednesday, and Friday.** We do not collect on weekends or major holidays. If a major holiday falls on a collection day, we will collect stallions on the following business day.

Please call our office at (205) 669-9118 to order semen. If there is no answer, please leave a message and we will call you back to confirm your order. Orders will be placed on our list in the order they are received including the timestamp on voicemails. If, and only if, your call will not go through, please send an email to <a href="mailto:southernequine@rocketmail.com">southernequine@rocketmail.com</a> or a text to (205) 728-3465. Emails and texts will be last priority. Please do NOT call our emergency line to place semen orders.

The stallion collection fee is \$300 per collection plus shipping. Shipping via Fed Ex will be charged according to the shipping address and the delivery date and time. The total for the collection and shipping will be calculated when the shipping label is created and a receipt will be emailed or mailed to the billing address specified on the shipped semen form. We will be happy to provide you with a total price on the day of collection once the shipment is completely processed.

Unless otherwise specified, Fed Ex Priority Overnight will be our preferred carrier. Some areas will have an option for Fed Ex First Overnight, which arrives sooner than Priority Overnight. If Fed Ex does not deliver to or is unreliable in your area, we can ship via UPS by special request. There will be an additional fee for UPS and Fed Ex First Overnight shipments.

Counter to Counter services are available via Delta Cargo if a suitable flight is available. Availability of airline shipments depends on air cargo routes operated by Delta Cargo and is subject to change due to weather or other unforeseen occurrences. The total will be \$550 for the flight, courier fee, and collection fee. Please specify up to two terminals on your shipped semen form.

Semen must be ordered and the delivery option specified by 8 AM CST on the day of collection. If you call to order semen, cancel your shipment, or change your delivery option (including airport destinations) after 8 AM CST, there will be a \$50 charge. Semen orders placed after 9 AM CST will be charged a late fee of \$100 IF we can fulfill the request.

Once your shipment is ready, we will notify the person(s) specified on the shipped semen form with the tracking or flight information.

Southern Equine Services is not responsible for any costs arising from or related to shipments lost, damaged, or delayed in transit or the condition of the cooled shipped semen upon delivery. We have no control of the shipment after it leaves our custody.

In order to keep our shipping fees as low as possible, we use disposable semen shipping boxes. **These shippers are NOT required to be returned.**
