CHAPTER AND ASSOCIATE MEMBER ACKNOWLEDGEMENT

By executing the Membership Application of Followers in Fellowship, Inc ("Chapter"), each undersigned applicant acknowledges and agrees to the following key provisions in exchange for approval of his or her membership application.

1. The Chapter is a subordinate organization of Followers in Fellowship, Inc. ("Followers in Fellowship") and exists to operate exclusively for charitable, educational, and religious purposes within the meaning of Internal Revenue Code Section 501(c)(3); to preserve and advance Christian education in the United States; and to engage in any and all lawful activities appropriate to carry out those purposes.

2. The Chapter is managed by a Manager appointed by Followers in Fellowship. It also is governed by the terms of an Operating Agreement entered into by Followers in Fellowship and the Manager. The Member may obtain a copy of the Operating Agreement upon request made to the Manager.

3. The undersigned Member will cooperate with the Manager in good faith and comply with reasonable instructions from the Manager made in accordance with the Operating Agreement of the Chapter. The Member agrees to act in accordance with the terms of the Operating Agreement of the Chapter.

4. The Manager may at any time select and admit a person as a Chapter Member. Education programs or activities of local groups within the Chapter must be led by a Chapter Member. The admittance of a person as a Chapter Member, and all activities of all Chapter Members, shall be subject to approval by Followers in Fellowship. The Manager also may admit a person as an Associate Member designated by either the Manager or a Chapter Member.

5. A Chapter Member or Associate Member may be removed by the Manager or Followers in Fellowship at any time with or without cause.

6. The Chapter will operate exclusively as the sole chapter of Followers in Fellowship in territories selected by Followers in Fellowship.

7. The Chapter will operate in accordance with all chapter policies and regulations adopted by Followers in Fellowship, which shall be provided to all Chapter Members and Associate Members.

8. The undersigned agrees to pay all annual membership dues assessed by the Chapter and any fees charged for special activities of a group within the Chapter. The Chapter will provide advance notice to Members of any such dues or fees to be charged.

9. The Member acknowledges and agrees to the following:

- a. Chapter's Statement of Faith, which is the Apostle's Creed.

- b. The Member performs background checks for persons working directly with children or youth.
- c. The Member will hold both Followers in Fellowship, Inc. and the Chapter harmless from any and all liabilities, losses, claims, judgments, suits, fines, penalties, demands or expenses, claimed by anyone by reason of injury or damage to persons or property as a proximate result of the acts or omissions of the Member.
- d. The Member will provide proof of Commercial General Liability insurance of a minimum value of \$1 million, including Sexual Abuse liability naming the Chapter as an additional insured.

10. In the event that the Manager of the Chapter, after consultation with the Chapter Members, determines that the Chapter no longer wishes to be affiliated with Followers in Fellowship, then the Manager shall notify Followers in Fellowship in writing and Followers in Fellowship may dissolve the Chapter and distribute the assets to itself or to some other charitable organization for the purpose of fulfilling its charitable, religious, and educational mission.

11. Followers in Fellowship has granted to the Chapter a non-exclusive right to use (but not to modify) all trademarks, logotypes, or other symbols of Followers in Fellowship, as well as all copyrighted material owned by Followers in Fellowship (collectively, "Proprietary Material"). However, the Member shall not allow any third party to use such Proprietary Materials without the written consent of Followers in Fellowship in accordance with the Chapter Operating Agreement.
