PERMIT TO OPERATE **HEAVY CONSTRUCTION EQUIPMENT** DURING EVENING OR WEEKEND HOURS

CBJ Title 42.20.095 makes it illegal to operate heavy construction equipment before 7:00 a.m. or after 10:00 p.m., Monday through Friday, or before 9:00 a.m. or after 10:00 p.m., Saturday and Sunday, unless a permit is first obtained from the City and Borough Building Official. Such permit is to be issued by the Building Official only upon a determination that such operation, during hours not otherwise permitted, is necessary and will not result in unreasonable disturbance to surrounding residents. This permit does not allow disturbance of the peace and is intended to prevent construction noise which may disturb residents during the night time hours.

5 pm to 7 am for Night Work PERMIT REQUIREMENTS: (Permit shall be invalid if the following requirements are not adhered to) I. Notification of neighbors-:

A) Place Public Service Announcements (PSAs) in local newspaper and at least 3 local radio stations at least 4 hours but no more that 3 days before noisy activity starts. Suggested announcement:

"Notice of Heavy Equipment Operation. On (date), (company) will be operating (type of machinery) at (address) between the hours of (start) and (end) under the conditions of noise permit number (number). This permit does not allow unreasonable noise disturbance after 10:00pm or before 7:00am weekdays and before 9:00am on weekends. Please contact (company) at (telephone no.) if you have questions. Contact the Juneau Police Department at 586-0600 to report unreasonable noise disturbance or other permit violations."

- B) Notify residential neighbors within 300 feet of site by "door knockers" or letters at least 24 hours before activity starts. Announcements must include the information suggested in the PSA above as a minimum.
- II. Do not idle noisy equipment unnecessarily.

III. Limit operation of noisy equipment to the least amount of time practical.
