## RESIDENTIAL STEEL SECTION WARRANTY

**LIFTER GARAGE DOORS** warrants the door sections against defects in material and workmanship as well as deterioration due to rust through (defined as metal perforation) in residential single-family, owner-occupied installations for five (5) years as long as the original purchaser owns the home, and for up to three (3) years in all other residential installations from date of delivery to the original purchaser. This also includes warranty against delamination (defined as separation of front and back steel skins). This warranty specifically **EXCLUDES** weather-stripping which is subject to wear under normal usage. This warranty **EXCLUDES** rust resulting from damage to the door section caused by fire, other accident or casualty, scratches, vandalism, harmful fumes or chemicals, condensation or occurring due to any physical damage to the door.

This warranty **DOES NOT** apply to any damage or deterioration caused by abuse, applied paint failure or failure to provide reasonable, necessary, and proper maintenance, or any other causes beyond **LIFTER GARAGE DOORS** control, nor shall these warranties extend to or cover any damages or claims with respect to any product that in any way have been altered, processed, misused, or improperly handled or installed. This warranty applies to residential products only and is not valid in commercial applications.

Under the terms of this **LIMITED WARRANTY**, for any door components that are found to be defective upon inspection by authorized **LIFTER GARAGE DOORS** personnel, **LIFTER GARAGE DOORS** will, at its option, repair or replace the defective components. Labor charges, shipping costs, paint or painting or other building materials shall be the responsibility of the consumer.

**LIFTER GARAGE DOORS** shall not be liable for any consequential incidental damages. All other warranties, expressed or implied, including any warranty or merchantability are hereby **EXPRESSLY EXCLUDED**.
