Please see my responses in red. [RLGG comment: Red comments are from councilors P. Banks & J.Banks]

The following submission is in regard to the actions and verbal accusations of these 2 Councillors at the May 13th, 2024, Municipal Services Committee (PW) meeting where Councillors J. and P. Banks attempted to silence a delegation of a local public opinion group, the Rideau Lakes Grassroots Group (RLGG). They did so by seeking to remove this public delegation from the agenda and making several unfounded, unsubstantiated, derogatory and false accusations about RLGG as well fellow councillors, at an open meeting.

I understand by telling the truth in public it may cost us both up to three months pay but we cannot continue down this road. Councillors Maxwell have caused a divide in council and have publicly supported the RLGG while lying to council, staff and the public for nine months about their help in creating this political group.

We have asked for help in closed meetings many times and tried twice in open, one of those on January 29th and our mayor has refused to step up.

The RLGG is not an opinion group, they are a political machine used secretly by two sitting councillors to sway public opinion using hate, conspiracy theories, lies and deception. Their main objective since August 2023 is to pressure 5 council members into building a new HUB/Office instead of retrofitting the current Chantry office.

Our defence is the truth.

Grassroots Members:

Marcia Maxwell: Rideau Lakes Councillor of 5 years, was also involved in a right of way lawsuit with Jeff and Paula Banks, where she lost money.

Wendy Alford: Ex Smiths Falls councillor, who lost in the last election and is friend of councillor Maxwell according to her.

Howard French: Ex Reeve Rideau Lakes and campaign manager for Laura Redman in 2023 by- election.

Laura Redman: Candidate in 2023 by -election against Paula Banks, self proclaimed political reporter and RLGG member. The person that councillor Paula Banks asked council for protection from several times starting in June 2023 and the same person that ended up assaulting councillor Jeff Banks at a council meeting in November 6th 2023 while in attendance with Howard French.

Dan Berty & Lesley Ullyett: Main spokesman for the RLGG and his partner.

There were no false statements or accusations made by councillors Paula or Jeff Banks about the RLGG or fellow council members. All statements made are true and were made in the public meetings only after being discussed in depth numerous times in closed or through emails with no resolution from councillors Maxwell being offered.

Maxwell have had nine months to address the deep division they have caused in council. During many closed meetings they have chosen to either stay silent or be untruthful, until recently.

Council, the CAO and the clerk have been made aware of their RLGG membership and aid, this was planned to be discussed on the closed agenda for the May 13th 2024 meeting, maybe that is why the delegation chose that meeting.

Knowing this, the CAO felt it necessary to make the unprecedented move of sharing with all council the planned RLGG delegation on the same meeting prior to setting the agenda. This is the first time in councillor Jeff Banks 25-year history of politics this has happened, that is unprecedented.

Both councillors Maxwell were made aware of this closed meeting and the planned discussions. Yet when the delegation came forward, they both chose again to hide from the public their membership in the RLGG. Councillors and Maxwell helped create and have aided RLGG since its inception with distributing flyers attacking 5 of their fellow council members because they refused to spend 8.5 million on a new HUB/Office.

Not only did they not make that partnership known publicly, they voted for this delegation to go forward knowing this group was printing conspiracy theories and lies undermining the township and that divided council and the community with their help.





All council members were made aware 6 days prior to the May 13th meeting that someone had came forward after the May 6th meeting claiming that these flyers were distributed during the team building BBQ. Councillor Paula Banks asked all council members on three different occasions if this person was being truthful. She explained that a person had reached out after watching the May 6th meeting and said they were at the BBQ and saw a councillor distributing boxes to other councillors at the Chantry office, August 17th 2023.

All of council were aware this was going to be discussed during the closed meeting. Staff reached out immediately to councillor Paula Banks assuring her they felt they were not copied in the building and mentioned this was the first they had heard of the flyers even being in Chantry.

If this was not true, every single member of council could have taken the same initiative staff did and let councillor Paula Banks know it was false. Councillor Paula and Jeff Banks never said this is true, they said they are looking into seeing if it is true. Councillor Maxwell could have cleared this issue up just as staff had done by coming forward.

Instead like the last nine months they chose silence and tried to undermine the meeting and the truth coming out by supporting the delegation of RLGG. They have all been made aware through meetings and emails many times that this group was printing lies and conspiracy theories only attacking 5 members. Councillors Maxwell once again stayed silent and voted for this delegation to go forward. This was not transparent, truthful or appropriate. This included the mayor, who has referred to this group as an opinion group knowing in fact that they have printed conspiracy theories and lies that have caused mistrust in the community, disharmony in staff and divided the current council like none in the past. His poor leadership and refusal to denounce these lies and speak to the deception of two seasoned councillors have brought us to this point.

Councillor P. Banks reiterates public accusations

The RLGG is a political attack group that have spread lies and false conspiracy theories about the majority of TRL council with the help of two council members secretly being part of their group. Both of these council members have vehemently denied their participation in helping RLGG for nine months until recently.

We attempted to remove or defer this political group due to the fact that two of our sitting councillors had just confessed to helping start the RLGG by distributing the original blue flyers attacking the majority of TRL council.

Councillor Maxwell after calling the tax payers that originally reported her for distributing flyers, liars, now claims she was just helping her friend, Wendy Alford. All council members, the CAO and Clerk were aware that the secret membership of our two council members in this group was scheduled to be discussed in a closed meeting later on the same agenda May 13th.

We felt it inappropriate to let a political group that spread lies and false conspiracy theories be allowed to speak before we were allowed to ask these two council members questions about why they misled staff, council and the public for nine months about their aid and membership to the RLGG.

These accusations have been discussed at length in closed meetings and emails within council, the CAO and clerk. At any point in the last nine months councillors Maxwell could have addressed our concerns by telling the truth, they chose not only to hide it but to try to undermine us from getting to the truth by allowing this delegation to go forward while hiding that they have been helping the RLGG since its inception.

Specifically, I refer to the following sections of By-law 2019-17, Schedule B Code of Conduct:

Section 1.2.i and 1.2 iv, Section 3.1, Section 5.3 ii, Sections 6.8.1, 6.10.1, 6.11.1, and 6.11.2.

To provide some context to the purpose of the delegation, at the Regular Council meeting of May 6th, 2024, Councillor Paula Banks, while attempting to rationalize her violation of the Township's Code of Conduct

Prior to the May 6th meeting councillor Paula Banks was told if she did not attend the closed meeting where her IC complaint was discussed as is her right, she would be allowed to defend herself from councillor Maxwells complaint of disrupting a meeting in an open meeting. That did not happen.

Under Conduct at Council and Committee meetings 6.8

Section 6.8.1

During Council meetings members shall conduct themselves with decorum. Respect for deputations and for fellow members and staff requires that all members show courtesy and not distract from the business of Council during presentations and when other members have the floor.

For the breach here of this section I ask that you view the most recent council sessions covering the special budget meetings on January 29th and January 30th. Specifically the first 10 minutes of each of these meetings.

At the May 6th meeting the mayor did not let councillor Paula Banks speak and made several efforts to cut her off. She finally asked to submit a written defence, that cannot be found on any public record, why? How will this case be any different, if found guilty when can councillors Paula and Jeff Banks defend themselves so the public can have access to that defence.

Councillor Paula Banks defence was that she was going to ask council for help, yet again from the RLGG and councillor Maxwell. Due to being aggressively confronted in public while accompanying her four-year-old grandson by an angry RLGG member.

councillor Maxwell took part in those closed and open discussions and voted to take 21 days pay from councillor Paula Banks without making their membership or their part in creation of the RLGG known to staff, council and the public. In fact, this motion had failed and councillor Pollard asked that it be brought back to the table without making his membership and support of the RLGG known.

, blamed her behaviour on others and, specifically, RLGG, calling them a hate group, falsely accusing them of physical and other forms of harassment without evidence or substantiation. RLGG requested the delegation to raise awareness about the group and to correct these statements for the public record.

The RLGG is the reason councillor Paula Banks was asking for help on January 29th during the budget meeting. As reported to council and staff on January 26th councillor Paula Banks was at the dollar store in Smiths Falls with her four-year-old grandson when she was confronted by a person claiming to be a RLGG member. This member verbally attacked the "Banks councillors "angry over the pickle ball and included an accusation that the money was being spent at the hall in Portland instead of in South Emsley. This person was aggressive and made councillor Banks feel for her personal safety and that of her young grandson.

(exhibit A Defence Final Draft).

The RLGG including councillors Maxwell as members, have harassed the five members of the majority of council and they bullied us relentlessly since August 2023 because we refused to vote to support the mayor's 8.5 million HUB /Office project.

Their members have verbally and physically attacked us at council meetings and in public. When attempting to answer questions they deflect or answer nonquestions as will be seen when you read their answers that were asked of their delegation (exhibit B Answers to delegation questions).

Councillor Paula Banks was attempting to ask again for help due to feeling unsafe January 29th when Councillor Maxwell filed a complaint that she was disrupting the meeting. Councillor Maxwell at that time was not transparent about her membership in the RLGG when she filed the complaint with the IC investigator or when she and councillor Pollard voted to take 21 days pay from councillor Paula Banks.

The RLGG members have escalated from on line hate to in person verbal attacks with a young child present, to a physical assault in the Chantry Council office. Laura Redmond, who she herself claimed is a proud member of RLGG came to a meeting with spokesman Howard French. Their group were cat calling council members the whole meeting and at the end Ms. Redman moved chairs in front of her out of the way to advance to the council table and spat at councillor Jeff Banks. This was witnessed by several council members and reported to staff and the OPP.

Staff after reviewing the tape confirmed they felt something had happened and as the mayor also mentioned she was banned from the building.

When asked by the OPP if he wanted to charge Ms. Redman, councillor Jeff Banks said he did not want to make the situation worse or cause someone to lose their career. An assault charge we were may prohibit Ms. Redman from her current career as a realtor. In hind site she should have been charged.

The OPP officer said he would pay a visit to Ms. Redman home and speak to her about the possible ramifications to her actions and let her know she is lucky we were not pressing charges.

All of this can be confirmed through the OPP Rideau Lakes Detachment.

The RLGG and its members came to the meeting looking to cause turmoil and the mayor allowed it to escalate into an assault.

All of council needs to publicly denounce these ongoing attacks on the majority of council from the Rideau Lakes Grass Roots, John Fenik and Laura Redmond.

We have contacted the OPP about Ms. Redmond's latest escalating behavior. They asked us if we wanted her charged but as we said we do not want to ruin anyone's life, but her behavior continues to get more outrageous and dangerous when she is our presence. The only difference in this case is we have witnesses to it. They have spoken to her and this will stay on file in case there is another issue with her.

However, the township of Rideau Lakes leadership had a duty to protect us, including our health and safety and they failed November 6th.

I find it upsetting that no one on council including the CAO and Mayor even tried to put a stop to this before it got out of hand. Even though I have had two closed meetings suggesting something like this being a real possibility, I have explained how her poor behavior was escalating and asked you to ban her from committees of council or representing Rideau Lakes in any manner. Her behavior should not have not been a surprise to anyone.

From the moment the Grass Roots came to the council meeting they were disruptive and disrespectful to the majority of council yet not a word was mentioned. Yelling out comments and making rude sounds.

Even after I asked the chair to interject to their comments and sounds, nothing was done. Both Council Hutchings and myself brought their behavior to the attention of the CAO and chair and again nothing was done.

They should have been ejected from the meeting earlier and Mr. Redmond had no business approaching the council table at the end of the meeting. This according to our own procedural bylaws the Grassroots claimed they were there to protect.

She literally had to wait for John Clarey to leave so she could move a heavy chair and come up to Councilor Hutchings to hiss then over to Councilor Banks to spit.

It is clear there is very little reality in her statements and zero remorse. She needs to be banned from the Chantry office and Rideau lakes sponsored events.

From the Grass Roots we need to denounce their information, they never ask questions or fact check and publish slanderous and incorrect information on a consistent basis. For one example but I can also provide many many others.

Our belief

There is an effort to assume control of the township decision making processes, by a "group of 5" councillors who form a majority when voting together on township matters. They very frequently align with each other and vote as a block to disregard the sound advice of senior township staff on material financial planning and governance matters.

They have conspired to stack the powerful Planning Advisory & Committee of Adjustment by expanding the committee to ensure all 5 are on it. What follows is a summary of relevant aspects of the discussion and proceedings of the May 13th MSC (PW) meeting and where I believe the Code of Conduct has been contravened. Refering to the video of the May 13th meeting, I will specify the time in the video, identify the Councillor(s) speaking, the general content of their remarks, the relevant section(s) of the Code and how I believe it was contravened.


Councillors Jeff and Paula Banks

Time: minute 1:32 thru 1:44

Councillor Paula Banks moves to amend the agenda by removing the RLGG delegation.

Councillor Jeff Banks seconds the motion.

Councillor Paula Banks asked for the RLGG delegation to be removed. The Clerk confirmed that this was permitted so did the CAO in an email prior to this meeting offer that as an option.



The RLGG is a divisive group attacking the majority of council with lies and false conspiracy theories that council members and staff are aware of. Councillor Banks asked to defer the delegation until council got more information about two council members that were part of creating the RLGG and confirmation that the that flyers were handed out of the Chantry office as recently reported.

Councillor Maxwell speaks to the right of the group to speak, but fails to be transparent about how she membership in this group that attacked her fellow members.

Councillor Maxwell called three tax payers liars for claiming she was distributing flyers as part of the RLGG, but the mayor got upset councillor Paula Banks claimed that councillor Maxwell were lying because they had confessed, they were.

Maybe if the mayor had of dealt with councillors Maxwell when they confessed this would have been resolved instead, he did not say a word. This can be verified by watching the closed meetings. The mayor silence on the RLGG knowing they were printing lies and conspiracy theories against the majority of council should call for his resignation. Mayor Hoogenboom watched for the last nine months in silence pretending that the RLGG was not a political machine used by councillor Maxwell and claimed they are a simply opinion group as he often states.

The mayors comments to concerning the RLGG delegation even tough he has been asked several times to speak to the lies and conspiracy theories and refused each time.

Hoogenboom said there have always been critics of the mayor or members of council and this group is probably no different, "but it is the council that is the voice of the community. It's not one particular group or individual."

"Social media is a wonderful tool but it needs to be fair and it needs to be appropriate," he said. "How well we do our jobs will be decided by the public at the next election."

The difference is councillor Paula Banks had proof that

Maxwell had lied because they had confessed in front of other councillors and staff days earlier. When councillor Maxwell said three tax payers were lying, she did that in closed and we all now know they were telling the truth.

Violation: Sections 1.2.i, 1.2.iv, 3.1, 6.11.1, 6.11.2 (particularly TRL By-laws 2019-17 Schedule D and 2023-48 Section 14)

Rationale:

In attempting to remove a public opinion group from the agenda, Councillors J. and P. Banks were seeking to silence a public group representing local constituents with whose opinions they did not agree. This contravened the spirit of Federal and Provincial laws regarding public access and

transparency, specifically the Municipal act, as well as the Township's own by-laws.

RLGG followed the Township procedures for seeking a delegation on the agenda which was granted;

The CAO offered councillor Paula Banks this route as an option in an email. If those options offered broke any municipal, provincial or Federal laws I would speak to her. The RLGG has always claimed that no council member was part of their group as we now know that is also a lie. I would suggest they were not being transparent

and may have broken several laws and bylaws by secretly working with two council members to pressure other council members to vote for a new office by harassing them for nine months.



Township offices meet no standards, council chambers are a joke

To Rideau Lakes' Mayor and Council:

In 2015 "TRL's Strategic Plan-2015 and forward - visioning for 2025" set the parameters for what Rideau Lakes would look like in 10 years. Municipalities must be thinking at least 10-15-25-50 years into the future when it comes to their infrastructure, what the priorities will be and the priorities and course for the municipality. In that exercise, one of the things identified was the development of a municipal hub. For the next several years many actions were taken to prepare for a municipal hub including several public consultations and the purchasing and clearing land (Bresee and Gallagher properties) to set the foundation for that to become a reality. There is also documentation that since the Portland Hall was considered "beyond it's useful life" that the Hall property would also be utilized for a municipal hub which is in a geographically appropriate place for the entire township and in line with hubs in other wards. In January 2023, having all of the studies, assessments, estimates and architectural work completed, the CAO recommended the tender be let. That would then set the stage for applying for federal/provincial funding to assist with the building of the municipal hub. There are 440+ municipalities in Ontario and each municipality prepares their package for large capital projects. Mostly those that are shovel ready (meaning all of the pre-work has been completed) will make the short list for federal/provincial funding which was the case with the Municipal Hub project. The municipality's multiple Councils and staff had been working toward this since 2015 -- nearly 9 years. Current council stopped that process and embarked on an ill-advised path toward a Portland standalone hall/library that serves only Portland and area and abandoned the needs of those residents in other wards along with the staff and others who conduct business with the Townshin.

If I simplify this into its essence ou could say that a library/hall utlilized so little should not take priority over the administrative offices for the entire Township. The office in Chantry was the only place to put the Township's offices when amalgamation was enacted and it was at the same time we were experiencing the 1998 ice storm and the recovery from that emergency so there were few better choices in that moment when turning five townships into one. That was only to be a short term solution but here we are 25 years later. The Chantry office was started life as a Public Works garage and

other than building internal offices it hasn't changed that much....it is deficient and substandard in every way for the efficient and effective operation of a 15 million dollar a year business which is what the Township is. It is not on a main thoroughfare, it is not technologically appropriate, it won't meet 2025 AODA (accessibility) requirements, it has no climate friendly features, it could not be a command and control structure in an emergency (and that is not an "if" there is an emergency....that is a "when"), there is not sufficient room to conduct business with residents or others doing business with the Township in the offices and the Council chambers is a joke. There

are rodents and the sodium level in

the water there has meant water will

be brought in. All that said, there

are no redeeming qualities in the

current Chantry office. There are

43 employees of the Township (22+

in the Chantry office) and their abil-

ity to respond to all of the demands of the 11,000 souls in Rideau Lakes is made infinitely harder without the tools of their trade. needed a snowplow or a fire truck we would buy it but we have not been able to provide a decent working environment for the people that work for us. Resources are not endless and capital projects must be planned and budgeted for and sources of funding will have to be found. It is highly unlikely that federal/provincial funding could be found for the building of a hall/library at a cost of \$3+ million dollars means less resources available for something that is truly needed. That was made even more unlikely when current Council dismissed any climate friendly additions to the hall/library. The hope had been that a single construction project could solve the administrative offices problem and the perceived need for a hall/library but Portland rejected that. There are 3 other halls in Portland and 2 others close by and the library is currently housed so if only one project is going to move forward, it should be the administrative offices.

There is currently, according to the Township's auditor, only \$2 million dollars in reserve and \$770,000 of that will be used for the Fire Hall which everyone agrees is a priority. If the rest of the current reserve and any borrowed funding is used for the standalone hall/library that will use up the financial resources needed to build municipal offices and pushes it far into the future.

This current Council has the ability to reverse course again and restore the original plan for the Hub (perhaps with some modification in the spirit of collaboration) and I respectfully request you do so.

I was not going to reply to this but then I got clarification today on one important issue in my training today.





Morning,

As per the procedural by-law the Mayor or Clerk can call a special meeting; the Mayor of his/her own accord, or the Mayor/Clerk based on a majority of Council petitioning them to do so. However, the meeting mut provide 48 hours' notice. The only exception to that is a meeting called by the Mayor on an emergency basis. Accordingly, in the absence of the Mayor calling it as an emergency meeting, no Council would not be able to have a social meeting before PACA, as that would not allow 48 hours' notice. The 48 hour period would commence once the majority position was provided (I would suggest in writing, by email is fine no need for a formal 'oetition') and the Clerk can issue the notice.

In terms of the request for a closed meeting – while discussion about concerns of the conduct of a member could qualify for closed, the issue of the flyer circulating in the community does not look to be something that would qualify. That discussion would have to occur in open.

As I have noted before if there are concerns about a member's conduct in relation to the Code and you believe you have expressed this to the member and the members behaviour has not changed in a manner that you believe is complying (informal resolution technique), you may be best to refer the matter to the integrity Commissioner (either as a member, group of members, or formally as Council if the majority direction occurs at a meeting of Council).

While I will leave it to the Mayor to respond, I do not believe he believes his conduct in discussing the development path in Portland and his opinion on the relative value of one option versus any other is a breach of

Getting an Integrity Commissioner to review and rule on the matter may be the best way forward for all to address this matter — as it allows for independent and impartial review and once determined, will allow the matter to rest. You could ask the IC for an expedited review noting the disruptive nature of the matter to the business of Council.

As I have noted to some on inquiry in the past, I would be concerned about unilaterally seeking to impose any sanctions or limitations on a member absent an IC review and finding of a breach of the Code due to either 1) the unclear legislative authority to do so or 2) the fairness/due process of doing so absent a finding by the IC that a breach has indeed occurred.

In terms of the flyer, if Council directs a certain action to be taken and provides the necessary details to do so (i.e. the noted idea of a media release, with desired language/primary points) staff will follow through. However, when it comes to specific issues that are highly partisan and/or political in nature, staff cannot act at the direction of one member (or even a majority outside of formal direction at a meeting). So indeed, if the majority position is that the Township should respond in some fashion to the flyer, that direction should come via a meeting, as you noted.





As noted in Section 1.2 of the TRL By-law 2019-17, Schedule B, "Members of Council shall seek to serve the public interest by upholding both the letter and spirit of the laws of the Federal Parliament and Ontario Legislature, and the laws and policies adopted by this and other Municipal governments."





Add to that the renewed libelous attacks from RLGRG I want to address these false accusations. I have decided to defend myself from just Marcia complaint to the IC. She choose to submit it so we knew it was her and did not ask for it to be confidential so I can speak to it publicly according to who I spoke to.
