We support the H.O.P.E. Sponsorship program of the local NGO we support. We recruit sponsors, manage their donations, and grant the donation to the NGO. In 2024 over 230 children were sponsored. The sponsorship funding we grant ran three project sites that offer the children a 6 day a week drop-in program. Children receive a daily meal, hygiene supplies monthly, and educational supplies for school throughout the school year, a school uniform, supplemental clothing/shoes, and medical care as needed. The funding pays for all the services to the children, it pays the facility rent for the drop-in center, and covers the salaries/expenses of running the program and having staff. Additionally, 170 more children who were unsponsored participated in the program.

We support a local NGO in Addis Ababa, Ethiopia called I Care Ethiopia. We sent funding to them for their administrative use, and education, and food support. We also provided them with a grant for their women's empowerment program that was used for income generating activities for women giving them training and support to find a job or start a small business. We also provided funding for them to open a free daycare center for the women to use for their children.

We support a US-based 501(c)3 called Streets of Hope. They have a program in Sodo, Ethiopia. The funding we grant them goes to their 501(c)3 organization and is then transferred to their program in Ethiopia. They help over 130 vulnerable families in Ethiopia.
