We support the H.O.P.E. Child Sponsorship Program of the local NGO we support. We recruit sponsors, manage their donation, and grant the donation to the NGO. In 2018 over 300 children were sponsored. The sponsorship funding we grant ran five project sites that offer the children a 6 day a week drop-in program. Children receive a daily meal, hygiene supplies monthly, and educational supplies for school throughout the school year, a school uniform, supplemental clothing/shoes, and medical care as needed. The funding pays for all the services to the children, it pays the facility rent for the drop-in center, and covers the salaries/expenses of running the program and having a staff.

We granted funding to the NGO we support for a women's empowerment program. Vulnerable women, mostly widows, were given training and capital to start a small business. They were also added to an on-going support group. This was an income generating project.

We granted funding to the NGO we support for their main office overhead expense. Those expenses include office supplies, travel, rent, staff salaries/pension fund.
