INVESTIGATION: Civil Matter

LOCATION: 500 N 158th St in Gilbert, AZ

NARRATIVE:

On 01-22-2023, at approximately 1944 hours, I was dispatched to a call for service of a civil matter at the above listed location in Gilbert, AZ. Call

comments advised the reporting party (RP), later identified as Katelyn Beazley, requested a civil standby at the listed location in Gilbert, AZ but the homeowner refused to let her in to retrieve dogs belonging to her. Katelyn was waiting outside the listed residence.

Officer Palenik and I responded to Katelyn's location, and she told me the following:

She tried reaching out to the homeowner of the residence she was standing out front of because the homeowner, later identified as Kimberly Hansen, was a partner of an adoption company they started together and felt Kimberly was mistreating the dogs. She wanted to retrieve several dogs and property located at the residence, but Kim never answered her phone calls. When she went up to the front door and knocked and requested to retrieve the dogs, Kimberly's

husband, Todd Hansen, greeted them and told them to get off their property. She promptly did so and called the police.

In an effort to keep the peace, I requested Katelyn and the other people she

brought with her to standby at a different location and away from the residence while we spoke with the homeowners. Officer Palenik and I contacted Kimberly and Todd and they invited us inside the residence. Kimberly told me the following:

She and Katelyn started an adoption company "Advocate for PAWSibilities", after a tragic incident with her daughter. She said Katelyn and she have equal rights to the dogs in her residence. She did not receive any texts or calls from Katelyn to advise she was on the way to get the dogs. She advised even if she spoke with Katelyn, she would not give up the dogs to her. She said Katelyn had a key to the residence but has no other right to be at the residence.

I advised this seemed to be a civil issue and the police department would not get involved. Officer Palenik and I were shown the dogs and they seemed well taken care of despite being rescue dogs from around the nation. Officer Palenik and I met with Katelyn at a nearby store and advised her the matter at hand was civil. Katelyn was adamant about showing me paperwork she was the sole owner of the company, and requested a report be taken. I reiterated to Katelyn Gilbert Police will not get involved in the civil matter. I provided Katelyn with a report number.

CONCLUSION:

This case will be NON-CRIME RESOLVED.
