- 6) That the permission is accorded to “Sai Baba Educational Society, Akkayapalli, Kadapa Mandal” and no other society or body can open a School on their behalf.

The Inspecting Officer i.e., Mandal Educational Officer, Kadapa caused inspection and submitted his report in the reference 5th read above.

In exercise of powers conferred in the G.Os 1st to 4th read above and after careful examination of the proposals of the Society and on due consideration of the inspection report of the Inspecting Officers in the reference 5th read above, Renewal of recognition is hereby granted for the classes I to V (EM) in the name of Saibaba E.M. Primary School under the management of “Saibaba Educational Society, Akkayapalli, Kadapa” for the academic years 2019 – 2020 to 2028 – 2029 without aid now or in future subject to fulfillment of the following conditions.

- 6) That the permission is accorded to “SAIBABA EDUCATIONAL SOCIETY, AKKAYAPALLI, KADAPA” and no other society or body can open a School on their behalf.
- 7) The permission is accorded to open the School premises in the locality and there shall not be any change in the premises of locality.
- 8) The society shall provide the necessary material even if it costs more than the deposit amount.
- 9) The Society shall submit the No objection Certificate from the Department of Fire Services while submitting the proposals for grant of Renewal of recognition, if failed so, the District Educational Officer, YSR District is liable to withdraw the permission without any prior notice.
- 10) Those Teachers who are working in Private Schools without possessing pass TET being conducted by the Andhra Pradesh School Education Department should invariably attend the TET and the managements should confirm their appointment only after passing the TET along with their regular qualification of D. Ed. / B. Ed, and other conditions stipulated by the Government from time to time.
- 11) Management should ensure to pay the minimum salaries to the Teachers by 1st of every month through bank.
- 12) All the Managements should ensure to reach every benefits like Gratuity, Teachers Provident Fund, Group Insurance Scheme etc., to the Teachers and other staff as per Rule 18 of G.O. Ms. No. 1 Education Department, dated: 01.01.1994.
- 13) All the Management should issue Identification cards to the staff working in their schools.

- 14) All the Managements should submit their Annual Administration Report in the prescribed proforma to the competent authority for very financial year by the 30th September.
- 15) The Inspecting Authority (Deputy Educational Officer/Mandal Educational Officer) inspect and verify the accounts including payment of the salaries and other benefits like Gratuity, Teachers Provident Fund, Group Insurance Schemes etc., to the staff.
- 16) The management should upload the fee collected by them during the academic year 2018 - 19 in CSE.AP.GOV.IN website and also display in two prominent places visible to public in respective school premises.
- 17) The Management shall submit the proposals for Additional Sections through the Mandal Educational Officer, Kadapa in accordance with the strength of the school immediately, if failed so, the District Educational Officer, YSR District will have the right to cancel the Renewal of Recognition issued in these proceedings.

Whereas, in the reference 7th read above Renewal of Recognition has been accorded to **SAIBABA HIGH SCHOOL, AKKAYAPALLI, KADAPA** for classes VI to X (EM) during the academic year 2007-08 to 2016-17 run by SaiBaba Educational Society, Akkayapalli, Kadapa.

The District Educational Officer, Kadapa has verified the application for grant of Renewal of Recognition with reference to the Inspection Report of the Deputy Educational Officer, Kadapa and also with reference to the conditions laid down in Renewal of Recognition order and submitted a report in his letter 10th read above.

After examining the references read above and the conditions prescribed in G.O.Ms.No.1 Education dated: 01-01-94, G.O.Ms.No.41 Education dated: 11-05-06, G.O.Ms.No.74 Education dated: 11-09-06, G.O.Ms.No.123 Education dated: 27-09-08, G.O.Rt.No.730 Education dated: 29-09-08 and G.O.Ms.No.80 Education dated: 15-07-09 the Regional Joint Director of School Education, Kadapa hereby accorded Renewal of Recognition to **SAIBABA HIGH SCHOOL, AKKAYAPALLI, KADAPA** for classes VI to X (EM) without aid during the academic years from 2017-2018 to 2026-2027 (10 Years) subject to the fulfillment of the following conditions.

01. That the society shall abide by the instructions/rules and regulations made by the Government or Authorized Officer from time to time
02. That the Educational Institution shall serve the needs of the locality more particularly.
03. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
04. The School times, Vacations and mid-term holidays shall be as prescribed by government from time to time.
05. That the qualified staff within the age limits prescribed by the Government for Government Employee shall be appointed as per the staff pattern.
06. That the results of institution shall be satisfactory every year.
07. That the records/accounts shall be furnished to the District Educational Officer every year 31st May at latest.

08. The Management is informed that as per G.O.Ms.No.1 Education dated:01-01-1994, the fee collection from the students shall be allocated as to meet the following requirements: -

- a) 50% of the fees collected shall be earmarked towards payment of salaries to the staff.
- b) 15% of fees collected shall be utilized for the maintenance of the institutions towards expenditure involving the building rent, electricity and water charges, stationery office payments to be made to menial and auditors, purchase of Library books, Lab Equipment and Chemicals and expenditure involving the upkeep of the institution etc.
- c) 15% of fees collected shall be earmarked for the developmental activities of the institution.
- d) 15% of the fees collected shall be earmarked as management's contribution towards staff benefits like gratuity, teachers provident fund, Group Insurance scheme etc.
- e) 5% of the fees collected shall be earmarked as personal income to the Management.

09. Library should be enriched with at least 1000 books.

10. E.W.F. Scheme should be implemented to all the staff members.

11. That the list of Governing body shall be furnished to the DEO every year.

12. That the pay structure/Fee structure fixed by the governing body shall be got approved by the DEO every year.

13. That all the conditions prescribed in the G.O. and other orders which are not specified in these orders shall be complied with.

14. That the School shall not be closed without giving notice both to the parents/ DEO and competent authority at least 6 months before.

15. That the school shall be closed for permitted to be closed only from the date on which summer vacation is declared.

16. That the society shall submit proposals for Renewal Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the order. However by the end of April every year, the Educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time.

17. That the Management shall submit the statement of Annual Accounts of the school duly audited by the chartered accountant at the end of every academic year.

18. The management should renew the Fire certificate and submit to the Regional Joint Director of School Education, Kadapa within one month.

The receipt of the proceedings should be acknowledged.
