

# **Privacy Policy**

**Effective Date: May 7, 2020** 

SideSpeak (the "Company," "us", "we", or "our") operates desktop, mobile and web-based applications (hereinafter referred to as the "Service").

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection, use, and sharing of information in accordance with this Privacy Policy. Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms of Service.

#### **Definitions**

## **SERVICE**

Service refers to the various web-based, desktop and mobile applications operated by the Company as well as the SideSpeak cloud service.

## **PERSONAL DATA**

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).



#### **USAGE DATA**

Usage Data is data collected automatically that is either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

### **COOKIES**

Cookies are small files stored on your device (computer or mobile device).

#### **DATA CONTROLLER**

Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal data are, or are to be, processed.

For the purpose of this Privacy Policy, we are a Data Controller of your Personal Data.

# **DATA PROCESSORS (OR SERVICE PROVIDERS)**

Data Processor (or Service Provider) means any natural or legal person who processes the data on behalf of the Data Controller.

We may use the services of various Service Providers in order to process your data more effectively.

## **DATA SUBJECT (OR USER)**

Data Subject is any living individual who is using our Service and is the subject of Personal Data.



#### Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

#### TYPES OF DATA COLLECTED

#### PERSONAL DATA

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Phone number
- IP address for your device(s)
- Cookies and Usage Data

#### **USAGE DATA**

When you access the Service, we may collect certain information automatically, including, but not limited to, the type of device you use, your device unique ID, the IP address of your device, your operating system, the type of Internet browser you use, unique device identifiers and other diagnostic data ("Usage Data").

## TRACKING COOKIE DATA

We use cookies and similar tracking technologies to track the activity on our Service and we retain certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags, and scripts to



collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

# Examples of Cookies we use:

- Session Cookies. We use Session Cookies to operate our Service.
- Preference Cookies. We use Preference Cookies to remember your preferences and various settings.
- Security Cookies. We use Security Cookies for security purposes.

#### **Use of Data**

SideSpeak uses the collected data for various purposes:

- To provide and maintain our Service
- To notify you about changes to our Service
- To allow you to participate in interactive features of our Service when you choose to do so
- To provide customer support
- To gather analysis or valuable information so that we can improve our Service
- To monitor the usage of our Service
- To detect, prevent and address technical issues

We will not sell your data to any third party for the purposes of marketing or advertising, or any other purpose.

# Legal Basis for Processing Personal Data under the General Data Protection Regulation (GDPR)

If you are from the European Economic Area (EEA), the Company's legal basis for collecting and using the personal



information described in this Privacy Policy depends on the Personal Data we collect and the specific context in which we collect it.

We may process your Personal Data because:

- We need to perform a contract with you
- · You have given us permission to do so
- The processing is in our legitimate interests and it is not overridden by your rights
- For payment processing purposes
- · To comply with the law

#### **Retention of Data**

We will retain your Personal Data only for as long as is necessary for providing the Service and for the purposes set out in this Privacy Policy, including to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes and enforce our legal agreements and policies.

We will also retain Usage Data for internal analysis. Usage Data is generally retained for a shorter period of time, except when this data is used to improve and strengthen the security and/or to improve the functionality of our Service, or we are legally obligated to retain this data for longer periods.

#### **Transfer of Data**

Your information, including Personal Data, may be transferred to and maintained on - computers located outside of your state, province, country, or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.



If you are located outside the United States and choose to provide information to us, please note that we collect the data, including Personal Data, in the United States and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that collection and processing.

We will use commercially reasonable efforts to ensure that no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

#### **Disclosure of Data**

### **BUSINESS TRANSACTION**

If we are involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice of any transaction in which your Personal Data is transferred and becomes subject to a different Privacy Policy.

#### DISCLOSURE FOR LAW ENFORCEMENT

Under certain circumstances, we may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency, subpoena, etc.). You will be notified of the request where legally permissible, and we will try to limit the amount and nature of the information disclosed to that of a "need to know" basis to the extent commercially reasonable. Once notified, you are also able to work with the requisite authorities to procure an injunction at your own cost and discretion.



#### LEGAL REQUIREMENTS

We may disclose your Personal Data in the good faith belief that such action is necessary to:

- · comply with a legal obligation
- protect and defend our rights or property
- prevent or investigate possible wrongdoing in connection with the Service
- protect the personal safety of users of the Service or the public
- protect against legal liability

# **Security of Data**

The security of your data is important to us. We will follow generally accepted industry standards to protect the Personal Data submitted to us, both during transmission and once we receive it, so that your data is treated securely and in accordance with this Privacy Policy, but remember that no method of transmission over the Internet or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

# **California Shine the Light**

Residents of the State of California, under California Civil Code § 1798.83, have the right to request from companies conducting business in California a list of all third parties to which the company has disclosed personal information during the preceding year for direct marketing purposes. ## **Service Providers**

# **Analytics**

We may use third-party Service Providers to monitor and analyze the use of our Service. These include:

### **GOOGLE ANALYTICS**

We use Google Analytics on our Site to help us analyze the traffic on our Site. ### **PAYMENTS**
