Education Foundation Update

Subject: Student Care Fund Information

Thanks Erica for your time today. I appreciate you taking this info to DTA for their feedback.

As I mentioned, YTD the Student Care fund has had requests totaling \$3,420 (12 requests). In all of last year, we had requests totaling \$3,520 (14 requests). While the balance in this account is still solid, we are looking to the future to make sure it's adequately funded to meet the requests we receive.

The Student Care fund originated when Dr. Wimmer was our superintendent. The idea behind the fund was to have funds available to fill short term emergency needs to support our students and their families that would reduce some of the barriers to learning for these students. This could mean funds for food, clothing, rent, and utilities (this is a greatly simplified version of the vision for the fund).

Several individuals in the community gave sizable contributions to initially fund it, and for many years, district employees have made monthly contributions through payroll deductions to the Student Care Fund and some give directly to the Education Foundation. There have been no comprehensive appeals in the recent past to raise additional funds, other than employee giving. Through retirement over the last few years, the number of employees and dollars contributed have diminished.

Currently, 14 district employees continue to contribute through payroll dedication to both the Student Care Fund and the Foundation General Fund, broken down as follows:

Student Care Fund – 6 teachers (\$62/month), 2 Classified (\$50/month) Foundation General Fund – 4 teachers (\$46/month), 2 Classified (\$30/month)

As you can see at this rate of \$122 / month, the annual contributions are falling short of meeting the needs being presented to us.

We are seeking feedback from the DTA to see if they feel an appeal to teachers, with a new program, such as The 232 Society, where teachers could give \$2.32 per pay check to the care fund though payroll withholding, would be something we should pursue.

Thanks for the help in soliciting some feedback for us.
