Dear Honorable Donald John Trump, President of the United States of America,

The correction of our **Tsalagiyi Cherokee Autochthonous Sentient Beings "Indians" of Turtle Island** identity, ethnicity/nationality shall be reflected **immediately** on all official and unofficial forms used in the fore mentioned offices, to replace African American/Black, American Indian, etc.

The Affidavit of Our Identity restores the Riteful Heirs to Our land now known as North, South and Central Americas, (Organic, Pangea). This Divine Covenant involves fulfilling Our God's promise to return Her Tsalagiyi Cherokee Autochthonous Sentient Beings "Indians" of Turtle Island to Our Ancestral Homeland after exile; ensuring land stays within families via Jubilee laws (Lev. 25), and foreshadowing Spiritual Inheritance, where the Heirs of Our God's promises Claim ultimate restoration in a new creation. as seen in prophets. It's a multifaceted theme of Divine Faithfulness, covenant, and the knowing of spiritual and physical dwelling with Our God.
