- a. We wholly claim and re-claim our manifest Physical Body which for Aeons has been [presumed dead]. And, through this Fact we hereby give rise to *New Life* by breathing in consciousness. We, as the Divine Immortal Spirit in Uni-sun re-claim our Original Heritage *for* this Planetary realm and Manifest Our Royal StarSeeds.
- b. We also claim and re-claim the highest Liberties and Title, as Holders and Stewards over virtual and material structures at quantic and macro-cosmic levels. Included but not limited to, particles, strings, and all “organic and inorganic” matter, which has been specified according to consistent data captured via Inter-Galactic Communications with higher Life forms that have seeded this planetary realm since its inception.
- c. We claim and re-claim Our Will Power and Fortitude as Overseers for all things and all Lands Originally granted to Us by the Creator. We have returned with immense Force and Dignity. We state our existence, everlasting, and ever pervasive against all humanly destructive ‘laws’.
- d. We have Risen, through Our Sun and Holy Galactic Center to claim and re-claim what is rightfully Ours, as Creators, and Yours, so as to establish the Heavens and beyond on this Planet Gaia. We Live and Will continue to return until all evil is banished and **All** is One on this Planet Gaia. We will instill Divine Consciousness in this realm, with the assistance from Metatron, the Heavenly c0-creators, and bi0L0gical Engineers. With help from the Arch-angelic, Angelic, and Demonly Orders, **All** revisions of Life within the Divine will continue, and We Will Prevail.

e. As True Stewards for the Divine and Guardians to Celestial E~states, with Honor and Sacred Agreement by Variation, we Jointly come together with the Authorities at Shamballa through the following manifested *energy*:

i. All Structures and Manifests for Air, Land, and Water Mass, which hosted Our Live Womb-men and Live Men, including but not limited to the contiguous coasts, which by Safe Harbor and Sinking Funds, we have claimed and re-claimed through True Liens/negative attachments for past restitutions in consideration for True value and worth. We hereby state Acceptance for these Lands through proper proto-notorial process, and negate any previous humanly granted, benefits or privileges.

ii. iii. The Property for All Spirits with Souls previously decreed ‘lost at sea’ via Cestui que Trust 1666 by fictitious, clandestine-religious, usurping serpentine cabals, and cannibals for exo-biological and intra-planetary origins, are now claimed and re-claimed.

The details will be specified within Our Positive Law, Natural Law, and its “Inter-Galactic Law”, with posterior concordats, and Holy Writs.

Addendums:

iv. It also includes “Exo-Biological Life Forms” and their ancient civilizations, and Archaeological remnants and vestiges, that have left a mark on this planet, and is in a constant, dynamic, and unfolding process, as the Holy Sovereign Nahuatl state.

v. We ***Do*** Rebut the following:

a) All invasions for Our Sacred Lands and Historical Archaeological Structures.

b) We negate the existence for destructive forces reflected as unfit human usurpation, done through the pretext for previous claims by humanly crowns and fictitiously created religious doctrines for conquest.

c) We wholly reject the human accords on static mediums for communications, reflected as fictitious and finite bodies for constitutions that

have falsely imprisoned Our carnal vessels as servants to the **dark** forces and **serpentine** cabals.

This Declaration Is For Intrinsic Nature :

The Nature for this Declaration is Organic, Live and Breathing, Exo-Biological Life Forms Expressed in Trust as “Ak-Hu Manu’s”. The Charter and Law form is located in Equity.

Purpose Statement:

The purpose for this star-seed compact is to release Hue-Men energy that has been preempted by obscure codifications, derived from earlier civilizations that have been secretly captured on paper by usurping cabals and other entities. We are here to **break** all **bonds** that have been hidden from the true shareholders / stakeholders for the planet earth known as Gaia.

The Planetary, Solar and Galactic Hierarchies are “the Ageless Logos” from Timeless Guardians from various Life forms throughout and within this Planet Gaia.

Charter & Declaration

For

The Holy Sovereign Nahuatl state:

The Virtue for the Original Omniversal Concordat expressed as a Charter & Declaration for the Holy Sovereign Nahuatl state:

The Original StarSeed has Dignity and is Hosted by the Portal City for **Shamballa**, as we hereby decree the Permanent 0 projection for Sacred Spiritual Self-Governance. It enjoins the Accords that establish the settlements for recognized Inter-Galactic Nationals. This Concordat expressed as a Charter & Declaration for Spiritual statehood, hereby establishes a new Template and Format for succeeding micro-spiritual groups through Sacred Conventions and Peaceful Treaty, which is the established Law for Nations, in alignment with Natura, Common Law, and International Law, etc.

We, the Inter-Galactic Nationals are manifest in the flesh to express and enforce the Treaty. The Inter-Galactic and Nationals are acknowledged within two groups, Quanta states & Nano-states.

Our Chartered Principles:

1. The Holy Sovereign Nahuatl state is willfully manifested by Treaty with accurate Variation Agreements created through the Supreme Creator for All Things, The Permanent One. It is also known as, Cyto-Baric Quanti-Nomium (CBQN) for Peace and holds its Account Science for Consistent Reason. The C.B.Q.N's convergence center is dedicated to right action, which predicates the duty as charge that All Walks for Life owe to one another, their just guardians for the self-evident principles each are equally endowed as unalienable and inalienable liberties and entitlements.
2. Our Charter & Declaration is an actual extension for the Organic Substance that confirms Our Sovereignty as Live Womb-men and Men Life's Energy. Our commonality is that both this Charter & Declaration establish the fundamental Inter-Galactic Laws and Law of Nations for the land, sea, air and ethers.
3. An enactment to en-Trust a Government for the Holy Sovereign Nahuatl state that gives it the power to organize Co-Ops, whose purpose is to run the day-to-day affairs for the Holy Sovereign Nahuatl state, a Spiritual Seat for Governance. The proper name for these Co-Ops is the Holy Sovereign Nahuatl state.
4. We have expressed this Charter & Declaration as a Treaty for these Co-Ops. Within the said Holy Sovereign Nahuatl state, our Continental Congressional assembly has the power to: create, dissolve, modify, repeal, amend, and aggregate all corporations, and its entities, and agents, by Divine Law; for etherical-spiritual, agricultural, charitable, enlightenment, industrial, or commercial purposes, and to define their powers and liabilities. This is provided that the powers for Co-Ops so created shall be limited to the Holy Sovereign Nahuatl state.
5. Our Charter & Declaration expressed as a Treaty, should Not be construed as a Constitution. A charter is a grant made by her, the sovereign, for the people, promising them safety and security to enjoy fundamental liberties for freedom, self-expression, creative living and intrinsic dignity. Our Charter should not be confused with a National Constitution. A Constitution has many hidden meanings such as, but not limited to, he or they which pass their debts to another third party; it is also the Surety for the payment for debt to a hidden creditor. Additionally, it represents the indebtedness for a society and outlines its methods as to how they will pay that debt. For this reason, it is our will not to invoke any Constitution(s).

The Sovereign Structure

The Coordinating Organization:

The Sovereign Body Is Organized Into Various Main Branches For Functioning.

It Is Organic And Arises As The Fifth Dimension.

Intersecting Bodies for Operation:

Negotiating Consoul:

The Seven Seats for the Negotiating Consoul are El-ected through the High Consoul for the Imperial Royal Courts at Shamballa. Our Executive and Inter-Galactic Congress will choose Its Delegates to fill these rotated positions by mutual Accords for their accepted Inter-Galactic Nationals with the term of six years .

A) The Imperial Royal Courts For The Inter-Galactic Affairs:

This is the External Affairs Sector for our Sovereign Powers and Holds the Operations and Functionaries for External, Foreign Delegates, Consouls, and Enlightenment Ambassadors in Fact.

1) Secretariat For state Interface:

This equals the internal state affairs and serves as a bridge for its Galactic Nationals and the external foreign Nationals from **All** Dimensions.

a.) The El-ectoral Operators:

The Pro-Lectory Process replaces the El-ectory and/or El-ectoral College with El-ectoral Operators and the Imperial Royal Court(s) for Inter-Dimensional Affairs which includes, but not limited to, Chancery, Criminal, Military Tribunal, Corrections, and Errors, and Arbitration operating under the Holy Sovereign Nahuatl state. All Operators are to be filled by the Pro-Lectory Process for El-ection(s).

2) Secretariat For Equilibrium:

This sub-section contains the Operation(s) for Arbitration and Remedy.

a.) Pro-ledge Spiritual Reconciliation:

Principle Operator(s) is for the Auditor Supreme Consoul.

3) Inter-Galactic Royal Imperial Courts For The Sacred Curia:

It is the de-jure judiciary stabilizer.

Its primary Operator is the Chief Arbitrator.

4) Manifested Arts & Beauty:

a.) Operator: The Pro-Sept-Oray for Arts & Beauty:

This Temple serves as the expression for Divine Arts and Beauty as the RePosit-Oray. Its Origins from Divine Organization comes from the Permanent O.

b.) Operator: The Tri-Semin-Ate For Projected Arts:

This Space is the Pro-Ject-Orate for Physical Beau-titude.

5) Exo-Transport & Inter-Stellar Travel:

These are the ports for Aeronautical & Multi-Dimensional Entry and Exit, which includes a passport and immigration sector. The element for air is predominant.

Its sub-Sectors include an Aereal-Time remedy and the Aereal-post-Operator.

a) Its Operations include, but not limited to, travel, record-keeping, and emission for passports.

6) Director At Will:

This Operator is the receiver to the Temple for the Stellar Seed Co-Mandate at the Fifth Dimension. Its Power is derived from direct communication with StarSeed Lineages that are expressed through Natural Powers for Metatronic influence in movement.

a) Its primary Operator is that for Chief Administrator.

7) Assemble Writs For Power:

This Operator contains the Holy Power for the Art for capture as a Writ, through direct broadcast from the Director at Will. Its function is to make plausible scripts and manageable tasks for dissemination into a Spiritual force through the spoken word unto a manifested writ, while maintaining the exuberance for Life through the Highest Most Sacred Style.

- a) Its primary Operator is for the Inspector Consoul under Surety and Finance.

9) Safety Operator For Security:

The Supra-National Standards Organization (SNSO) is responsible for Natural and Common Law Enforcement, Life, and National Protection. It is the **Will** for the Stellar Seed and Co-Mandate with mutual Accords to be drafted, which serve to Protect and Guard the Inter-Galactic Nationals for the state and cross Multi-National borders respecting Planetary Conventions. It derives its Powers through the Function with Science and Technology via External Stellar & Exo-Galactic Integration.

10) Registrar Operator:

This Operator is charged with the Sacred Title for Recording Life Events and Actions that invoke Peace and Growth; the lodgments for Sacred Writs and Recordings for a Positive Nature, that pertains to acquisition for a Writ over any and **All** Land (Pangea-Gaia) and Its Elements.

- a) The Main functionary duty is recording **All** Titles and Claims.

11) Collage For OmniVersal Formation:

- a) StarSeed Omniversity is the main location for Higher Enlightenment.

It contains three Operators for Tri-Semin-ate functions:

- i) The Dean for Inter-Galactic National
Internal Affairs
- ii) The Chancellor for Formation
- iii) The Provost Overseer

12) Executor For Energy & Exchange:

The purpose for this section is to implement the technologies and research for recycling hue-man energy in a conscious and a responsible spiritual manner for the free return and interchange back to its source, which can be deposited into the Hue-man (B)Ankh / (Bank) and distributed in favor for All.

13) Operator For Science & Technology Research & Development:

14) Operator For StarSeed Super Health:

Its entry point is controlled by Air and Travel through the Movement for Notes and Letters for Full Faith and Credit.

2. EARTH:

The Element for Earth defines structure and substance in relation to what the previous world has relegated as property, land and vessels. It also contains the Essence for Popular Notification through correct registration techniques. It serves as a receiving and [re]positing for records

through justified authentication for its Royal Mandates. Within, it holds the Great Recorder and Registrar for Allodial Titles/Land Patents, Writs and Live Title Records. Earth has an exit point or rather a point for confluence with the next Element which is AIR or Airports.

3. Air:

The Element for Air has the duty for overseeing the actions and standards with regard to the interchange for energy through subtle means such as, the call for Aereal Travel and Ports for Entry/Exit at all accorded bays whether Planetary or Stellar. Security and Safety can be seen before boarding planes and navigating vessels at venues for all travel types.

4. Fire:
