As a member in good standing of ABATE of Florida, Inc. you are covered by an accidental death and dismemberment policy. This policy pays out the principal sum of \$4000.00 for accidental loss of life, loss of both hands, loss of both feet, loss of sight of both eyes, loss of one hand and one foot, loss of one hand and sight of one eve. or loss of one foot and sight of one eve.

sight of one eye, or loss of one foot and sight of one eye. The policy pays out one half of the principal sum \$2000.00 for the loss of one hand, loss of one foot, or loss of sight in one eye.

Loss of hand means cut off through or above the wrist. Loss of a foot means cut off through or above the ankle. Loss os sight means blindness that cannot be corrected to at least 20/200 vision. Any loss must occur within 90 days of the accident causing the payable.





Also recognized Arlene who was delegate at June meeting, she is 92 and going strong. The allegation that we paid for the postage for the A.I.M. mailing are incorrect, we are reimbursed for postage. They do a lot of work PRO BONO. We have supported A.I.M. for over 20 years. Regarding statement Lobbyist doesn't give updates-both Doc & Mudder went over what we want to do this year in the President/VP seminars. . Doc & Patti met with accountant about C-3. Should be signing papers Monday 8/11/14, hopefully hear back from IRS in 3-4 months. We will not start collecting donations under the C-3 until we know it has been approved to prevent possible repayment and penalty fee issues. This will protect ABATE of Florida, Inc. financial status. Wants it back by March 2015 when session starts, we can say are now C-3 corporation. When we become the C-3 we should try to get the Motorcycle Training Program. Will bring in revenue to ABATE and funds will go to training, billboards, seminars, safety education for the benefit of all motorcyclists, and make it fair and equitable for everyone to take the course. Highway Safety told Doc no longer wants their name associated with of ABATE of FL, Inc. Nature Coast put in a request to close. Letters went out to members to see if 10 members will step up, if not they will fold.

Vice President Bennis "Mudder"Rudoi: No report.

Secretary Shelly Johnston: There was one correction to the minutes from the June meeting to include

the chapter elections are held in June and that the State Treasurer will be a signer on all bank accounts. Minutes were approved as corrected.

Treasurer Patti Nasrallah: Financial report in packets contain income/expense reports, balance sheet and detail of checks written. Doc recommended no more campgrounds after 2015. Need a vote on this from the chapters. We could get into the promotions/ concert business. Billy Bird will look into this. Don Kirkendale said many companies would pay postage for Masterlink just to reach such a large targeted audience. Doc said we cannot advertise insurance or cruises and get bulk rate.. Demetrius brought up idea of Finance Committee to review proposals and report to BOD pros/cons. Doc's concern is confidentiality of members, it would go to every member, but we would do the mailing. Doc formed new Finance Committee consisting of Don Kirkendale, Jim Burrow and Demetrios Kirkiles with Patti Nasrallah as Chairperson to look into business memberships, sponsorships and review proposals.

Sgt. at Arms Dennis T J Painter: Inventory sheets in packet, due at December State meeting. If it's late it affects the IRS filing. With high temperatures and humidity you will get dehydrated fast, watch your partner for signs also. Take closer look at bikes, check tires.

State Office Ms Boots: Officer updates still needed from a few chapters. Need copy of registration for trailers along with inventories. Look through inventory, make sure they are accurate. Flyers would be approved quicker if they follow flyer SOP. Must contain Abate of Florida, Inc. chapter's name, address of event, start and stop time. Just follow the checklist. Drawing tickets: every chapter should have letter in packet to take to treasurer and copy of tickets numbers the chapter has out. Has extra tickets here now-let her know if you need any.

Masterlink Editor Bob Alexander: There are 2 issues: hardware, software. The hardware problem is solved, working on software. Patti will work with him to allow a smooth transition. Patti said the Masterlink is about half done.

PR/Communications Sarabeth Kohl: Still needs to hear back from several chapters on whether they have Facebook page. Do not post negative comments, get facts straight before posting on social media. Page should be set up as an organization, not individual, and should not be able to send or accept friend requests. She must be admin on page, will not take posts down before discussing with Chapter PR. Pages should reflect our cause and mission: motorcycle safety and awareness and dedication to freedom of the road. Put in link to State's webpage.

Website Dan "Slo Mo" Henderson: In process of converting everything over, once done will be able to help chapters out

Safety Director Charlie Wenger: New MSAP certifications went to Charlie Black from Palm Beach, Jim Willard from Southeast, and John York, Ruth Kanowich, Kerry Walsh, Robert Walsh all from Daytona Beach. Push to get as many people certified MSAP as possible, those with certification should train other chapter members. Think out-of-the box when setting up places for safety booths. Safety item inventory also in packet, complete and return.

Products Trustee Steve "Caretaker: Knee: If you want Life Member or "Watch for Motorcycles" shirt and he does not have it in stock fill out order form and send to him along with payment. Item

should be in at next State meeting. The cost of the reflective back patch is \$50, Steve will look into it a little more, get cost on smaller quantity. Take back to chapter how many acorn patches and/or back patches the chapter wants, let Steve know so he can order and he will tell chapter how much. Spirit bells will cost about \$10 each, say ABATE of Florida, Inc. on one side and "safe passage" on the other. Took quick count of how many bells were wanted. He will order, they will take 4-6 weeks so should be here for next State meeting. He now has year pins in stock, up to 35 years.

Legislative Trustee Darrin Brooks: He is starting to see more about mandatory helmet laws in newsprint. He will be emailing sample letters to use for media and legislators. This is election year, have candidates come speak to your chapter, it's a good way to introduce them to ABATE while they are starting out. If you have a pro-motorcycle candidate (or anti) let him know so he can pass info on to Lobbyist. After the Primary he will be putting together a list of motorcycle friendly candidates. Slo Mo suggested talking to school board candidates also.

Lobbyist "Doc" Reichenbach: FL legislators were in special session Thursday 8/7 to redo some districts. This will affect some of us, including early voters. Stiffer penalties bill, safety money, driver's ed, discrimination bill, safety of the road are all things he will be working on. He will put out list of people he thinks we should support as his Lobbyist recommendation. Hoping to get a meeting with Gov. Scott.

NCOM: Next board meeting is in 11/14, convention May 2015 is in Denver, 2016 is Atlantic Beach. Motorcycle stops defeated. Would like to see a national discrimination bill instead of being addressed at state level. A few years ago the Monguls had their patch confiscated by the US government. They sued and won and now govt is appealing. This comes down to freedom of choice and if it doesn't stop who will be next? They are having a Save the Patch event 8/16 in Edgewater with proceeds going to the "Trademark Defense Fund". Info on NFLCOC website.

MRF / AMA: Transportation bill passed, didn't see anything about NHSTA. Darrin will check into. Nothing from AMA.

Bike Week March 6-15,2015: Ticket drawing Saturday March 14, 2015 noon. Doc met with fairgrounds and we cannot get out of contract. 2015 is last year of contract. Possibility of counter-offer was brought up, take this back to chapters and vote whether to keep campgrounds and/or counter offer. Need participation from all chapters to keep it profitable.

Tailahassee April 13, 2015: State meeting Sunday 4/12/15. Super 8 will work with us on room prices. We will line up in parking lot and road behind the Super 8 for the ride to the capital. If you go make sure you see your legislators.


PRESIDENT'S REPORT

PRESIDENT Doc Reichenbach: Asked delegates to sign in with their correct name and to write legibly. This is important if you ever want to run for office, your attendance has to be verified. Nature Coast chapter has been closed. Doc was informed today that Charles Wenger, the Safety Director, has resigned. Doc will be looking for someone to fill this position. He originally asked the Chapters to discuss the Bike Week campground with members, but an opportunity arose that enabled ABATE of Florida. Inc. to get out of the last year of the contract without financial penalty. This decision had to be made quickly and was unanimously agreed on by the BOD. Doc has received a letter to verify this. The campground has struggled the past few years and we only were in the black due to chapters donating or paying for supplies and the generator. Flyers must have exact wording for deductions per the SOP. Life cards picked up by delegates are to be given to chapter membership trustee to then be given to the member. Members cannot use ABATE of Florida, Inc.'s roster for their own private mailing. There will be no further mailings until unless it benefits the corporation. Any mailing except the insurance and AIM will be decided on by the delegation. He received a call from a chapter saying they weren't coming due to lack of funds, no excuses, each chapter needs to show up. Also, be careful driving. He hit a deer coming to the meeting- its hunting season and they are running.

VICE PRESIDENT Dennis "Mudder" Rudoi: Motorola did not distribute service manuals for our radios and will no longer fix them. Obsolete radios will be turned over to TJ. We now have 15

working radios each with 2 new batteries thanks to Hillsborough. The security trailer and pumpkin will be scrapped. The cook shack and box trailer will be stored. Mudder put out a challenge to all chapters to increase membership. He will give the chapter with the most new members and the chapter with the highest % of growth (based on size) over a 4 month period \$75. Don Kirkendall will add \$25, so the chapters will get \$100. Discussion followed on ways to get and keep members. Frenchie asked how do we keep members, Mudder said get them involved. The \$4000 ADD insurance is a bonus. SloMo suggested to share practices that work with other chapters. Safety products can generate new members.
