PRESIDENT DOC Reichenbach: The five chapters who hosted the State party would like to hold it again next year. They donated all the proceeds to State. Billy Bird said there was discussion that holding the State meeting the same day interfered with people attending the party. He suggested that the State meeting be held earlier in the day or Sunday. Doc said Sunday is when people travel back home. The BOD proposed to have the BOD meeting at 8 am and delegate meeting at 10 am. Other suggestions were to move the party to September or November. The committee will discuss possibilities and get back to the BOD. Doc talked to A.I.M. who sponsors our legislative hotline. They agreed to let us use the hotline for emergency updates during hurricanes and storms. They are doing this for every state. The hotline number is 1-866-352-2283 (1-866-FLABATE). Darrin brought up an ABATE app for smart phone. Doc talked to the person who does AIM's. Down the road we will have one. First Coast is officially closed. Do not send personal checks to State for any reason. It has to be a chapter check. The February State meeting place has been changed. It will be hosted by State and held in Ocala. See the flyer in your packet. Another motel that is not on the flyer is Sun Plaza Motel in Silver Springs, phone number 352-236-2343. The chapter who was supposed to host it notified State 2 days ago they could not. The BOD has decided that the bids for State meetings will be due in August, after elections in June and the new chapter BOD's are settled. If they decide not to do the State meeting after they committed they have 30 days to notify State. If they do not notify State during that time and do not fulfill their commitment they will be responsible for the costs of the meeting. Carol from Black Creek had a proposal for a change in the by-laws. Doc stated it needs to be turned into State Office two weeks before the State meeting. It will be heard at the February meeting. Doc asked about Duval's Christmas party and insurance, they said it was not an ABATE event.

VICE PRESIDENT Darrin "Scribe" Brooks: Been visiting chapters. Recommend chapters visit other chapters, but don't get involved with their business. Let's bring fellowship back into it

SECRETARY Shelly Johnston: There are no corrections to the minutes from the October meeting. Motion to approve by Seminole, 2nd by Daytona and passed.

TREASURER Patti Nasrallah: Financial reports are in the packets. Carol from Black Creek said according to the by-laws a budget is supposed to be prepared and submitted at the December meeting. Patti said she prepares income and expense reports every month. She has not prepared a budget because in order to prepare one she would have to get a budget from every chapter and they don't know what their income will be. Carol was expecting to know how we will cover State expenses. Patti said State's income comes from the 20% and memberships. Lake County, Peace River and Gator Alley have stepped up when State needed help. Doc said we went over this subject 4 months ago, and we're done with it. He asked if every chapter wants to do a budget and send it in so Patti can do a State budget. Response was NO. Patti will send out letters requiring budgets and we will have one next December. Inventories are also part of the budget. Motion to approve Treasurer's report by Lake, 2nd by Seminole and passed.

SARGENT-AT-ARMS Marcus Hotelling: Inventories are due today.

STATE OFFICE MS. BOOTS: Send your event flyer (see flyer SOP) first. Once it is approved send all the paperwork together: approved flyer, check for insurance, insurance request and property release. Insurance for a one-day non-riding event is \$125. Insurance for a ride is \$350 - \$379. One insurance wants to know how many will be attending, another wants to know how far the ride is.

MEMBERSHIP Laurie Hanley: Highest % of Growth in September was a tie between Forest and Vintage; October was Estero River. Lighthouse had the most new members in September; October was Southeast. No life cards. Let your chapter membership person know they are doing a great job.

MASTERLINK VACANT: There are copies of the Masterlink in front of the BOD table.

PR/COMMUNICATIONS Saily Carroll: Send flyers in JPG or Word. PDF does not post on Twitter. Flyers must be approved by State Office first.

WEBMASTER Dan "Slo Mo" Henderson: Template Works well on smart phones. No one has requested help with websites.

SAFETY DIRECTOR Victor Piorkowski: Victor Piorkowski: Has 14 schools coming up in January in the Fort Meyers and North Fort Meyers areas. Southwest is helping a lot, also Estero River, Gator Alley and Peace River. Question was asked where to get the MSAP class info- chapters should have received it at the Leadership Seminars. He is going forward to get more schools and help chapters break into their local schools. Inerstate has products to pick up. Question was asked to get yellow and black bumper stickers. We have a lot of the black and white that we need to get rid of. Doc will check on what we have for safety money and try to order some.

PRODUCTS Steve Knee: The new order form is in the packets. It has the "Biker Lives Matter" patch and shirt on it. Currently sold out of patch and shirt, you can order them. Delegates thought the lettering and circle wasn't bold enough on the shirts. Doc donated the money to have the stencil changed so the shirts can get out there.

LEGISLATIVE Darrin "Scribe" Brooks: While visiting chapters he is getting great feedback on the postcards they sent out. It is not too late to send them if you haven't already. Each chapter should reach out to their own Representative or Senator. They will pay more attention to their constituents' mail or emails. They can look up if you have voted in the past 5 years. If you vote in every primary and general election you're called a super voter and are important to them because you can get them re-elected. Know who your reps are. Go to myfloridasenate.gov or myfloridahouse.gov and put in your zip code + four and it will tell you who your reps are and how to contact them. The new Speaker of the House and Senate have picked their teams. You can call your rep and ask them to support a bill. Tell them you are a constituent, they will listen to you. Senator Clemens has submitted SB66, the Highway Safety Bill (our Vulnerable Road Users bill) and has added mopeds, scooters and animals. Motorcycles are not in the bill. There is no House bill yet. We are also expecting some type of helmet bill. Ask your rep to let you know if they hear anything to let you know. Currently he is sending emails to all chapter Presidents, VPs, Legislative Trustees and PR/Communications. If you would like to receive emails send him your email address.

LOBBYIST Doc Reichenbach: The new Speaker of the House is requiring lobbyists to go to school for 2 hours regarding new rules and procedures. We now will have to put in a bill for the safety money. Doc talked to a Senator who agreed to put in a bill for \$300,000 for safety money in the budget. He will also talk to Scott about not vetoing it. Doc may ask the Senator to come speak to us in February. If we get the \$ we will do a new safety video. We lost two Senators who were friends of ABATE. They haven't announced who will be on the committees in the House yet. Griz (Lake) said he would still like to see a mandatory driver's training course or you can't get your license till your 21. Motorcyclists have to, why not them. Florida is in the top 5 in teen fatalities. Maybe put in a bill that \$2 of every ticket goes to drivers ed programs. Doc will talk to a legislator about mandatory drivers ed.

LEGAL Larry Crow: All good and legal.

NCOM: The convention is in Reno May 11-14, 2017. In 2018 it is in Mobile, Alabama. Doc would like to see a good turnout from ABATE of Florida for that. He was asked if we would like to host a district meeting. He will be talking to other state presidents to see what they prefer.

MRF & AMA: AMA is dealing a lot with off road and racing. They contacted Doc asking for support to open all Federal lands to dirt bikes, ATV's, etc. He declined, he doesn't want any more land destroyed. Also, they are still working with EPA to lower the 15% ethanol. Trump has nominated someone to head the EPA who hates the EPA. The MRF is working on the anti-profiling bill and asked Doc to support. The bill dies in January so no use to support a dead bill and waste our political capital.

TALLAHASSEE 2017: The State meeting is Sunday April 9 and the ride to the capital is Monday April 10. Delegates voted to go. Last couple of years hardly anyone showed up. If we don't have a good turnout they will remember. Once we have the flyer put them everywhere.

OLD BUSINESS: No old business.

NEW BUSINESS: The gun drawing was a successful fund raiser. Doc asked the delegates if they would like to do it again for 2017 (another Henry and shotgun). Daytona Beach made motion to do it again, Seminole

2nd and passed. Doc will talk to Henry about doing a commemorative rifle for July 4, 2018. Darrin will send out an email on what Henry will allow. Delegates will go back to their chapters and get ideas together and bring to next State meeting.

GOOD OF THE ORDER:

Vintage birthday party Saturday January 28. Palm Beach has an event tomorrow. Question was asked where our portable mics were so everyone can hear. Lake County said they donated a PA system, speaker and cordless mics. The former Sgt-at-Arms picked them up and has not turned them in. Marcus will contact him to get them back. There also may be some in the inventory Brevard turned in. Thanks to the Gator Alley Galley Girls for the great lunch and to Gator Alley for hosting the meeting. Frenchie said the AIM mailing he received contained a 2016 calendar. Doc will ask them why not it was not a 2017.

PRESIDENT Doc Reichenbach: Doc letter from our insurance company, American Income Life, that 60 days from date of letter (5/25) they will be cutting off our insurance. AIL has paid over \$ 1/4 million in last 10 years to our members. Because the yellow information cards are returned to the State Office AIL has not gotten enough member participation with other insurance they offer. Doc told AIL that he hasn't talked to the agent in 2 years. Woman said she would talk to the higher up. If they continue use the yellow cards will have to go to the insurance company. The \$ 4000 has been a blessing to some families. It will be up to delegates if we still want to negotiate with them. In 2016 we had 2 deaths and 1 already in 2017. Forest chapter made motion 2nd by Southeast to negotiate with AIL to continue the \$4000 and that the yellow cards will be returned to AIL after they agree to keep the insurance. Seminole County asked if we could have the rep come talk to us at the President's Seminar. Every President needs to come to the seminar. Critter said the insurance is a big selling point for recruiting new members and some clubs require members to join ABATE of Florida, Inc. for the insurance. The yellow card also designates beneficiary so \$4000 won't be held up by state of Florida or taxed. Doc will call them Monday to offer them to speak at President Seminar and also at the NCOM convention in Orlando in 2019.

The NCOM BOD voted unanimously to hold convention here in 2019. It will be over Mother's Day weekend. The only problem right now is the hotel we used last time raised rate to \$169 a night. They are going to check with Doubletree. Larry Crow has resigned as our legal counsel. He has been disbarred but that doesn't affect us because he was not on any of our accounts. Jerry T. will now be the legal counsel for ABATE of Florida, Inc. only, not for members personal issues. Doc has received calls from reporters regarding the Leesburg situation. We have this standard answer: "No comment. We had nothing to do with it, we weren't there.

May was Motorcycle Safety Awareness month. Many chapters did proclamations for their areas. Proclamation on the state level is ABATE of Florida, Inc. responsibility. Doc will be closing Inerstate today. They want to stay in but no one wants to hold an office. We have 2 people who want to start a new chapter. Bryan (Woody) Short wants to start a North Orlando chapter. He knows a lot of bikers and he tells them about ABATE and how it connects everyone for a good cause, old members bring in new age members. Some sport bikers want to fight for their rights. Frenchie (Seminole County) said Orange County had 37 sport bikers-why wasn't he at their meetings. He responded that people he knew weren't interested

in joining Seminole County and he is not there for personal reasons. Also asked why shouldn't they be members? They have 16 potential members. They will bring modern ideas to ABATE. He has 4 people that want to be on their BOD. More discussion. Lake County liked his enthusiasm and youth. Peace River made a motion to accept the new chapter, 2nd by Treasure Coast. There was 1 abstain.

VICE PRESIDENT Darrin "Scribe" Brooks: Thanks to the chapters who gave money to continue the News Service of Florida. As of this morning we have raised enough money. ABATE of Florida, Inc. greatly appreciates all your help.

SECRETARY Shelly Johnston: There were no corrections to the minutes. Seminole County made motion to accept Secretary's minutes, 2nd by Freedom and approved.

TREASURER Patti Nasraliah: Financial report in packets. Went over several errors on the report. When she gets home she will send the corrected report to all chapter Presidents. We couldn't pay for the news service with the Leadership Seminars coming up we had to pay for the BOD rooms and meeting rooms. Question was asked how much is recommended each chapter donate to State to help with expenses. Patti said 10% would be fair to all chapters. Hillsborough motioned to accept Treasurer's report, 2nd by Polk and approved.

SARGENT-AT-ARMS Marcus Hotelling: Be sure your new BOD members go to the Leadership Seminars. They will learn a lot and get to meet other people in their positions.

STATE OFFICE Ms. Boots: Every chapter has drawing tickets out, return \$ and tickets to State Office once a booklet is sold. State meeting flyers need to have a map to the meeting hall! Don't send money with your flyer-price differs between poker runs, one day events and with camping it's quite a bit more. She will contact you about insurance cost.

MEMBERSHIP Laurie Hanley: The highest % of growth and most new members for March both went to Southwest. Lighthouse and Southeast tied for most new members in April and highest % of growth went to Lighthouse. Heidi has reached the top bracket of the membership incentive program and was presented with a shirt and pin

WEBMASTER Dan "Slo Mo" Henderson: Excused Absence. He will have CD's to hand out at the seminars.

SAFETY DIRECTOR Victor Piorkowski: Remind whoever puts on a safety booth that paperwork needs to be correct and complete with name and phone number. Send someone from your chapter to the safety seminar. Jim Owens from Seminole got his MSAP certificate and is now an instructor. Steve asked how are we going to get safety products? Doc said we still have money in the Safety and Education account and as soon as we find a vendor we will do an order.

PRODUCTS Steve Knee: Has products to be picked up. One year from today we will need a new products person.

LEGISLATIVE Darrin "Scribe" Brooks: We were able to squish the helmet bill. Thanks to a lot of work by our lobbyist and members of ABATE of Florida, Inc. in getting out information on why a helmet bill was not needed. Legislators were impressed by the calls they received and presentations. We are looking forward to 2018. Look at who's running in your area. Start paying attention to who is making noise about running. He will get a list together on people who are pro-motorcycle or not anti-motorcycle. Scott is going to run for US Senate. He has one more year as Governor. Adam Putnam will also be running for Governor and he is biker friendly. We will keep trying next year to get the safety money. Scott has been difficult to work with, not just us, but all groups.

LOBBYIST Doc Reichenbach: We have thought about doing a bill to rescind the \$ 2.50 fee motorcyclists pay at time of registration that is supposed to be for safety and education. We expect to get push back from Highway Safety & Transportation who is getting our \$2.50 which then goes into their General Fund to be used for any purpose. Doc is going to set up a meeting with Adam Putnam (and other gubernatorial candidates). The first question he will ask is would he sign a bill turning the safety program over to ABATE of Florida, Inc. The second question would be will he make sure there is money in the budget for us. We are going to put in for the money again in the 2018 session. Scott vetoed \$4 billion including education because his tourism money wasn't in the budget. Doc is going to request a \$ 300,000 grant from Highway Safety and Transportation. If they deny it he is going to request an audit. It became law 10 years ago that ABATE of Florida, Inc. would get the money. Five years ago they took money from all trust accounts because Florida was hurting for money. We have a Senator who wants to take motorcycles out of the Vulnerable Road Users bill but leaving in mopeds, golf carts, horses and bicycles. Passidomo got enough people to agree to take out motorcycle. The bill also says that if a bicyclist is in lane motorists must go over the line, even the double yellow line and pass them at a slow pace. He has sponsors for the bill in 2018 and will try to talk with Passidomo. Clemens also opposes us, saying we should not be protected because we don't wear helmets-bicyclists don't either. The helmet bill did not get a Senate sponsor. The rep who did the bill totally believes that we should wear helmets. We have the constitutional right to choose. Bicyclists will be talking with Doc, they want to work with us to get it passed. The 2018 session starts in January, we are riding to capital in February.

LEGAL Larry Crow: Larry Crow has resigned as our legal counsel. Jerry T. will assist ABATE of Florida, Inc. in all legal matters but is not available for personal issues.

NCOM: Reno convention was held May 11-14, 2017. It was the best convention yet. In 2018 the convention is in Mobile Alabama May 10-13, 2018. In 2018 it will be in Orlando Florida.

MRF & AMA: MRF-there is a new motorcycle caucus called Bikers in the Beltway with members in both the house and senate. Also working hard in national profiling. AMA-E15 is not labeled properly. Byron saw pump covering 3 different grades of E15. DO NOT use E15 in your motorcycles. Critter told of website, pure-gas.com that will show you where ethanol free pumps are. Doc has not heard anything about biodiesel. Shell gas is not recommended for some vehicles, consult with manufacturer guidelines. Sunoco, Citgo and Marathon are starting to get ethanol free.

TALLAHASSEE: Ride to the capital went well. If someone is paying the hotel for your group check your statements to make sure you weren't charged also. Hotel charged Doc's card and ABATE of Florida, Inc.

PRESIDENT'S REPORT

The last summer meeting has come and gone and now we look to the fall with the changing of the seasons and the migration of snowbirds coming to Florida. We will need to be even more aware of our surroundings when we ride. We are being hammered in the press about Florida having more accidents and deaths on motorcycles then any other state in the country. They never talk about the drivers only about us the riders. With next year being an election year we will be an easy target for our enemies to press for sanctions against motorcyclists.

We will make our wishes know in the Capitol at committee meeting this year and session in January. We have our vulnerable road bill and our safety money in this session. Then its election time for all the house part of the senate and a new Governor. It's time for changes in leadership in the Capitol for to long we have been treated like second class citizens and now we need to vote for people who support us.

I want to thank all the chapters for showing up at the past state meeting but we still have some miscommunication going back from the state meeting to chapter meetings. Make sure your notes are correct so the information gets out properly.

ABATE of Florida, Inc. speaks for the 900,000 licensed motorcyclists in Florida. That is a big voting bloc. We helped a House and Senate candidate narrowly win their seats (by 35 votes). It's all about working together. It's about freedom and protecting your way of living. The helmet law didn't get a hearing last year because our friends in the capital worked with us. If you want this lifestyle to continue you need to get involved. ABATE of Florida, Inc. is the last organization of freedom fighters in this state. When we speak to the legislators we are speaking for everyone. If you are tired of being an officer get new members and groom them for a BOD position. I'm willing to set the membership fee at \$15 to help build membership. Have been seeing chapters getting their names in the paper for supporting a charity. Charity begins at home. Thanked everyone who attended the Leadership seminars in July. The chapter Presidents learned about the situation with our ADD insurance directly from our AIL rep. Over \$250,000 has been paid out to ABATE of Florida, Inc. members and their families.

VICE PRESIDENT Darrin "Scribe" Brooks: If every chapter could at least sell 10 tickets to the Biker Bash we would be in good shape.

SECRETARY Shelly Johnston: There were a couple corrections to the minutes. Seminole County made motion to accept Secretary's minutes, 2nd by Freedom and approved.

TREASURER Patti Nasrallah: Bank accounts need to have \$500 balance. We now have credit card debt for the State meeting and Leadership seminars. The Hotline phone listed under expense is paid by Richard Lester

every 6 months. Beau (Vintage) asked that every chapter give \$100 so that the credit card balance could get paid off. He was told to bring it up again under new business. The rent on the State office is going up in October, it's time to leave it. There are things stored in there that chapters can use. We will get a storage unit to keep what we have to. Boots will get a list out of what we have, knows there are 2 safes from Brevard and a fire-proof cabinet. Chapters will have first choice and we will try to sell what isn't taken by chapters. We will need chapters to help move the stuff, chapter presidents will get an email when it's time to move. Sell the tickets- all chapter Presidents and Treasurers got an email. She also has the handouts that were not picked from the Leadership Seminars.

MEMBERSHIP Laurie Hanley: Forest Chapter got highest % of growth and most new members for May. Vintage got highest % of growth for June and North Orlando got most new members.

PR/COMMUNICATIONS Sally Carroll: Good to see everyone here today. As previously requested she has rates for Full Throttle and Rebel Rider. Rebel rider does not publish any articles political in nature. She needs to be made an administrator on chapter Facebook pages. She needs to friend the chapter admin in order to get in. If you have a Facebook page, use Twitter, Linked In, Google or UTube for your chapter you do need to sign the social media SOP's. Several chapters still have not handed theirs in. They were available at the seminars and Boots has extra copies also.

WEBMASTER Dan "Slo Mo" Henderson: All is fine. Contact Slo Mo if you need help with web designs.

SAFETY DIRECTOR Victor Piorkowski: If you have questions on motorcycle safety and awareness or how to get the program into the schools or how to get started and what you will need email, call or text him. Leave a message so he can get back to you.

PRODUCTS Steve Knee: No new shirts today, hopefully for next State meeting. Does have short sleeve life member shirts in medium and x-large. Also has a couple of "Bikers Lives Matter' shirts. Doc and Beau have received a lot of good comments on theirs. There is a new life member products form, prices have gone up a little...

LEGISLATIVE Darrin "Scribe" Brooks: Lake County finally did it-they boxed him in. We are halfway to another session. Campaign 2018: ABATE of Florida, Inc. members will be very educated on candidates and decisions. We want changes, we need to elect pro-motorcycle people. Share his emails with your members. Putnam now has an opponent, Jack Latvala. Richard Corcoran has opened an exploratory account so there is a possibility he may also run. The Democrats may be looking at John Morgan. Darrin will educate us on the

candidates but he will not come out in support of anyone yet so we do not alienate anyone. Contact him by email if you want to get his emails. Chapter presidents, vice presidents, newsletter, legislative trustees and delegates should be getting his emails already.

LOBBYIST Doc Reichenbach: Doc had meeting on Monday with the legislator who did the helmet bill last year. Since he is only allowed six bills he wants to do a bill that would pass rather than a bill that isn't going to be heard. He asked Doc if he would help him on an opioid bill. Doc said he couldn't speak for ABATE of Florida, Inc. but would personally say something. He also brought up the gang problem in Florida. Doc asked specifically what gangs. He said street gangs and other gangs. Don't be surprised if a gang bill is introduced. Doc told him since this is an election year there may not be any controversial bills as the legislators don't want to do bills that would make them unpopular. He told Doc he was surprised Doc didn't support the helmet law. Doc said he was surprised he didn't stand up for the people's rights. They agreed to disagree on that point. He did agree to speak to Governor Scott regarding the safety money. Charlie Stone (House) and Dennis Baxby (Senate) are sponsoring both the Stiffer Penalties Bill and the safety money. We have a lot of support for the safety money. It's the governor who keeps vetoing it. A lot of things ABATE of Florida, Inc. does is behind the scenes, such as no riding side by side or no more than 5 in a group which was stopped several years ago. Most bills are killed before they reach committee. We may have a problem in 2018 Clemens, who is anti-motorcyclist, will be the leader of the senate. Will be bill to get the safety funds and an amendment to put the money back in a trust fund so they cannot use it anymore. Let Doc or Darrin know what's going on locally. Committee meetings start next month. Question was raised if we were going to try to get a Purple Heart tag for motorcycles again. Doc will try to attach it on another bill. Another question about the red white and blue motorcycle specialty tag. ABATE of Florida does not get the money. It is divided between charities which represent possible injuries to motorcyclists. In return they agreed they would not support a helmet law.

LEGAL COUNCIL: Doc: we do not have an attorney sitting on the board. We do have one that will be handling things for the corporation.s.

NCOM: The convention will be in Mobile Alabama in 2018. It is close enough that you could go if you wanted to. You will see you it is run and what it's all about so in 2019 when we host it in Orlando we will know a little more. They have set up a committee for a seminar that will probably talk about helmets.

MRF & AMA: AMA is still working on the 15% ethanol issue. Do NOT put it in your motorcycle-it will eat it up. There are pumps with 40-60-80% ethanol out there-they are for flex fuel cars. MRF is also working on the 15% ethanol. They are also looking for sponsors for the national profiling bill. Doc has not been contacted by anyone who has been profiled.

TALLAHASSEE: The ride to the capital will be Monday February 12, 2018. The State meeting will be Sunday February 11. It will be cold. Last year only 80 people showed up. That makes us look bad when we have thousands of members. We voted to go. When asked who was going most of the delegates raised their hands. We need chapters to go, other bikers to go. We need a strong showing. We are locked and loaded when we go to the capital. We have facts to back us up. Discussion about motels and campgrounds near the staging area for the run. Doc will look for another motel when he goes to the capital again.

BIKER BASH Billy Bird: Friday 11/3-Sunday11/5. If every chapter buys 10 tickets it will be a great success

and lots of \$ will go to State. Gator Alley will be running the bar and is accepting donations of bottles of alcohol (\$ also). Doc reminded delegation that people wanted to have a State party again but 2/3 of did not raise their hands indicating they were going. Buy presale tickets-you will save \$5 and will help them to know how many people to expect and plan for. This is an adult party. Children will not be allowed beyond the gate. The Memorial tent that Hillsborough used during Spooks and Scoots will be displayed during the party.

OLD BUSINESS: Chapters to host the 2018 State meetings are: 2-11-18 State (we are in Tallahassee). 4-14-18 Peace River 6-9-18 Lighthouse 8-11-18 North Orlando 10-13-18 Gulf Coast 12-8-18 Gator Alley.

PRESIDENT'S REPORT

It's been a couple of weeks since the last state meeting but I want to thank Peace River for hosting the meeting. As usual they did a great job. This letter is only going to deal with a situation that came up today in the Florida legislature.

Today I received an update from the Florida legislature that will affect every MOTORCYCLIST IN THE STATE IF IT PASSES. It is House Bill 419 and will require every rider in the state to carry the exact same insurance as automobile. What that will mean is we will have to carry PIP. The insurance companies have never liked this because it could put us off our motorcycles and the cost could be atrocious. This is a call to arms check with the legislative officer to find out what committees this bill is going to and who are on the committees. You need to contact your legislators and tell them to vote no on this bill.

House Bill 2018 will put \$300,000 in Abate of Florida, Inc's hands for Motorcycle safety.

House Bill 117 and Senate Bill 116 both are our vulnerable road user bills.

Senate Bill 346 requires moped riders under the age of 21 to wear a helmet but the problem is they could place a amendment on it that would require all of us to wear a helmet.

It sounds like open season on all motorcyclists. Now is the time if you have never called you legislators and you want to remain free then call the abate legislative officer and then call your Senator and House member tell them vote NO on HB 419 and Senate Bill 346.

The next state meeting will be in Vero Beach we will really discuss these bills and the impact they could have on us. Until then Ride Safe and Free!!!

House Panel Backs Red Light Camera Repeal HB6001.

HB215and SB 504 relates to autocycles, which by definition have two wheels in front and one in back. This will change the definition of a motorcycle.

Darrin brought up an ABATE app for smart phone. Doc talked to the person who does AIM's. Down the road we will have one. First Coast is officially closed. Do not send personal checks to State for any reason. It has to be a chapter check. The February State meeting place has been changed. It will be hosted by State and held in Ocala. See the flyer in your packet. Another motel that is not on the flyer is Sun Plaza Motel in Silver Springs, phone number 352-236-2343. The chapter who was supposed to host it notified State 2 days ago they could not. The BOD has decided that the bids for State meetings will be due in August, after elections in June and the new chapter BOD's are settled. If they decide not to do the State meeting after they committed they have 30 days to notify State. If they do not notify State during that time and do not fulfill their commitment they will be responsible for the costs of the meeting. TREASURER Patti Nasrallah: Financial reports are in the packets. Carol from Black Creek said according to the by-laws a budget is supposed to be prepared and submitted at the December meeting. Patti said she prepares income and expense reports every month. She has not prepared a budget because in order to prepare one she would have to get a budget from every chapter and they don't know what their income will be. Carol was expecting to know how we will cover State expenses. Patti said State's income comes from the 20% and memberships. Lake County, Peace River and Gator Alley have stepped up when State needed help. Doc said we went over this subject 4 months ago, and we're done with it. He asked if every chapter wants to do a budget and send it in so Patti can do a State budget. Response was NO. Patti will send out letters requiring budgets and we will have one next December. WEBMASTER Dan "SIO MO" Henderson: Template Works well on smart phones. No one has requested help with websites.

SAFETY DIRECTOR Victor Piorkowski: Victor Piorkowski: Has 14 schools coming up in January in the Fort Meyers and North Fort Meyers areas. Southwest is helping a lot, also Estero River, Gator Alley and Peace River. Question was asked where to get the MSAP class info- chapters should have received it at the Leadership Seminars. He is going forward to get more schools and help chapters break into their local schools. Inerstate has products to pick up. Question was asked to get yellow and black bumper stickers. We have a lot of the black and white that we need to get rid of. Doc will check on what we have for safety money and try to order some.

PRODUCTS Steve Knee: The new order form is in the packets. It has the "Biker Lives Matter" patch and shirt on it. Currently sold out of patch and shirt, you can order them. Delegates thought the lettering and circle wasn't bold enough on the shirts. Doc donated the money to have the stencil changed so the shirts can get out there.

LEGISLATIVE Darrin "Scribe" Brooks: While visiting chapters he is getting great feedback on the postcards they sent out. It is not too late to send them if you haven't already. Each chapter should reach out to their own Representative or Senator. They will pay more attention to their constituents' mail or emails. They can look up if you have voted in the past 5 years. If you vote in every primary and general election you're called a super voter and are important to them because you can get them re-elected. Know who your reps are. Go to myfloridasenate.gov or myfloridahouse.gov and put in your zip code + four and it will tell you who your reps are and how to contact them. The new Speaker of the House and Senate have picked their teams. You can call your rep and ask them to support a bill. Tell them you are a constituent, they will listen to you. Senator Clemens has submitted SB66, the Highway Safety Bill (our Vulnerable Road Users bill) and has added mopeds, scooters and animals. Motorcycles are not in the bill. There is no House bill yet. We are also expecting some type of helmet bill. Ask your rep to let you know if they hear anything to let you know. Currently he is sending emails to all chapter Presidents, VPs, Legislative Trustees and PR/Communications. If you would like to receive emails send him your email address.

LOBBYIST Doc Reichenbach: The new Speaker of the House is requiring lobbyists to go to school for 2 hours regarding new rules and procedures. We now will have to put in a bill for the safety money. Doc talked to a Senator who agreed to put in a bill for \$300,000 for safety money in the budget. He will also talk to Scott about not vetoing it. Doc may ask the Senator to come speak to us in February. If we get the \$ we will do a new safety video. We lost two Senators who were friends of ABATE. They haven't announced who will be on the committees in the House yet. Griz (Lake) said he would still like to see a mandatory driver's training course or you can't get your license till your 21. Motorcyclists have to, why not them. Florida is in the top 5 in teen fatalities. Maybe put in a bill that \$2 of every ticket goes to drivers ed programs. Doc will talk to a legislator about mandatory drivers ed.

LEGAL Larry Crow: All good and legal.

I will be making a template for you to use when you go and visit your legislators in Tallahassee. The venerable road users bill S432 and H541 are amendments to 316.2127. S408 would change the venerable road users bill to take out the word motorcycles.

motorcyclists and let them know there is a helmet bill in the legislative process this year. I have talked with Patti regarding updating the legislative information on the web site.

LOBBYIST Doc Reichenbach: the current information regarding our bill will be up on our website. We had no one step up to handle the Masterlink. Now we have state board members trying to do 2 jobs. If you know how to do these jobs you need to step up and help out.

The bill was put in three weeks ago and has not been assigned to a committee yet. When HB1609 came out I spent 3 hours with the sponsor. We talked about several items that pertain to motorcyclists including our safety money.

Please do not ask people from out of state to call our legislators. I talked to one legislator that got a call from someone from out of state that was very nasty to him. Session starts the first week in March. The Speaker of the House wants to stop all the amendments that are put on a bill at the end of session. I had made the announcement earlier that I want all chapter presidents and vice presidents email address before you leave here today.

LEGAL Larry Crow: Larry Crow has been excused from this meeting.

NCOM: The next NCOM convention will be in Reno, Nevada May 11-14, 2017. For 2018 it will be in Mobile, AL. We were asked if we wanted to do a regional meeting or convention in Florida. I want to welcome the new North Orlando chapter that was voted in at the June meeting and we are looking forward to having another chapter join shortly. It is great to finally see young people getting involved to start learning the process to fight for their rights.

I had discussions with the life insurance company and the \$4000 death and dismemberment policy has been reinstated. American Life has paid out over \$250,000 to our members in the past ten odd years. It has been a blessing to our members and their families.

I again want to thank our members for all their support through the years and please when you're out riding be aware as these cars and trucks don't see you. The officer training seminars are July 7-8 in Ocala. Until then dodge the raindrops and 'Ride Safe and Free!!!!!

PRESIDENT Doc Reichenbach: Doc letter from our insurance company, American Income Life, that 60 days from date of letter (5/25) they will be cutting off our insurance. AIL has paid over \$ 1/4 million in last 10 years to our members. Because the yellow information cards are returned to the State Office AIL has not gotten enough member participation with other insurance they offer. Doc told AIL that he hasn't talked to the agent in 2 years. Woman said she would talk to the higher up. If they continue use the yellow cards will have to go to the insurance company. The \$ 4000 has been a blessing to some families. It will be up to delegates if we still want to negotiate with them. In 2016 we had 2 deaths and 1 already in 2017. Forest chapter made motion 2nd by Southeast to negotiate with AIL to continue the \$4000 and that the yellow cards will be returned to AIL after they agree to keep the insurance. Seminole County asked if we could have the rep come talk to us at the President's Seminar. Every President needs to come to the seminar. Critter said the insurance is a big selling point for recruiting new members and some clubs require members to join ABATE of Florida, Inc. for the insurance. The yellow card also designates beneficiary so \$4000 won't be held up by state of Florida or taxed. Doc will call them Monday to offer them to speak at President Seminar and also at the NCOM convention in Orlando in 2019.

The NCOM BOD voted unanimously to hold convention here in 2019. It will be over Mother's Day weekend. The only problem right now is the hotel we used last time raised rate to \$169 a night. They are going to check with Doubletree. Larry Crow has resigned as our legal counsel. He has been disbarred but that doesn't affect us because he was not on any of our accounts. Jerry T. will now be the legal counsel for ABATE of Florida, Inc. only, not for members personal issues. Doc has received calls from reporters regarding the Leesburg situation. We have this standard answer: "No comment. We had nothing to do with it, we weren't there.

May was Motorcycle Safety Awareness month. Many chapters did proclamations for their areas. Proclamation on the state level is ABATE of Florida, Inc. responsibility. Doc will be closing Inerstate today. They want to stay in but no one wants to hold an office. We have 2 people who want to start a new chapter. Bryan (Woody) Short wants to start a North Orlando chapter. He knows a lot of bikers and he tells them about ABATE and how it connects everyone for a good cause, old members bring in new age members. Some sport bikers want to fight for their rights. Frenchie (Seminole County) said Orange County had 37 sport bikers-why wasn't he at their meetings. He responded that people he knew weren't interested

in joining Seminole County and he is not there for personal reasons. Also asked why shouldn't they be members? They have 16 potential members. They will bring modern ideas to ABATE. He has 4 people that want to be on their BOD. More discussion. Lake County liked his enthusiasm and youth. Peace River made a motion to accept the new chapter, 2nd by Treasure Coast. There was 1 abstain.

VICE PRESIDENT Darrin "Scribe" Brooks: Thanks to the chapters who gave money to continue the News Service of Florida. As of this morning we have raised enough money. ABATE of Florida, Inc. greatly appreciates all your help.

SECRETARY Shelly Johnston: There were no corrections to the minutes. Seminole County made motion to accept Secretary's minutes, 2nd by Freedom and approved.

TREASURER Patti Nasraliah: Financial report in packets. Went over several errors on the report. When she gets home she will send the corrected report to all chapter Presidents. We couldn't pay for the news service with the Leadership Seminars coming up we had to pay for the BOD rooms and meeting rooms. Question was asked how much is recommended each chapter donate to State to help with expenses. Patti said 10% would be fair to all chapters. Hillsborough motioned to accept Treasurer's report, 2nd by Polk and approved.

SARGENT-AT-ARMS Marcus Hotelling: Be sure your new BOD members go to the Leadership Seminars. They will learn a lot and get to meet other people in their positions.

STATE OFFICE Ms. Boots: Every chapter has drawing tickets out, return \$ and tickets to State Office once a booklet is sold. State meeting flyers need to have a map to the meeting hall! Don't send money with your flyer-price differs between poker runs, one day events and with camping it's quite a bit more. She will contact you about insurance cost.

MEMBERSHIP Laurie Hanley: The highest % of growth and most new members for March both went to Southwest. Lighthouse and Southeast tied for most new members in April and highest % of growth went to Lighthouse. Heidi has reached the top bracket of the membership incentive program and was presented with a shirt and pin

WEBMASTER Dan "Slo Mo" Henderson: Excused Absence. He will have CD's to hand out at the seminars.

SAFETY DIRECTOR Victor Piorkowski: Remind whoever puts on a safety booth that paperwork needs to be correct and complete with name and phone number. Send someone from your chapter to the safety seminar. Jim Owens from Seminole got his MSAP certificate and is now an instructor. Steve asked how are we going to get safety products? Doc said we still have money in the Safety and Education account and as soon as we find a vendor we will do an order.

PRODUCTS Steve Knee: Has products to be picked up. One year from today we will need a new products person.

LEGISLATIVE Darrin "Scribe" Brooks: We were able to squish the helmet bill. Thanks to a lot of work by our lobbyist and members of ABATE of Florida, Inc. in getting out information on why a helmet bill was not needed. Legislators were impressed by the calls they received and presentations. We are looking forward to 2018. Look at who's running in your area. Start paying attention to who is making noise about running. He will get a list together on people who are pro-motorcycle or not anti-motorcycle. Scott is going to run for US Senate. He has one more year as Governor. Adam Putnam will also be running for Governor and he is biker friendly. We will keep trying next year to get the safety money. Scott has been difficult to work with, not just us, but all groups.

LOBBYIST Doc Reichenbach: We have thought about doing a bill to rescind the \$ 2.50 fee motorcyclists pay at time of registration that is supposed to be for safety and education. We expect to get push back from Highway Safety & Transportation who is getting our \$2.50 which then goes into their General Fund to be used for any purpose. Doc is going to set up a meeting with Adam Putnam (and other gubernatorial candidates). The first question he will ask is would he sign a bill turning the safety program over to ABATE of Florida, Inc. The second question would be will he make sure there is money in the budget for us. We are going to put in for the money again in the 2018 session. Scott vetoed \$4 billion including education because his tourism money wasn't in the budget. Doc is going to request a \$300,000 grant from Highway Safety and Transportation. If they deny it he is going to request an audit. It became law 10 years ago that ABATE of Florida, Inc. would get the money. Five years ago they took money from all trust accounts because Florida was hurting for money. We have a Senator who wants to take motorcycles out of the Vulnerable Road Users bill but leaving in mopeds, golf carts, horses and bicycles. Passidomo got enough people to agree to take out motorcycle. The bill also says that if a bicyclist is in lane motorists must go over the line, even the double yellow line and pass them at a slow pace. He has sponsors for the bill in 2018 and will try to talk with Passidomo. Clemens also opposes us, saying we should not be protected because we don't wear helmets-bicyclists don't either. The helmet bill did not get a Senate sponsor. The rep who did the bill totally believes that we should wear helmets. We have the constitutional right to choose. Bicyclists will be talking with Doc, they want to work with us to get it passed. The 2018 session starts in January, we are riding to capital in February.

LEGAL Larry Crow: Larry Crow has resigned as our legal counsel. Jerry T. will assist ABATE of Florida, Inc. in all legal matters but is not available for personal issues.

NCOM: Reno convention was held May 11-14, 2017. It was the best convention yet. In 2018 the convention is in Mobile Alabama May 10-13, 2018. In 2018 it will be in Orlando Florida.

MRF & AMA: MRF-there is a new motorcycle caucus called Bikers in the Beltway with members in both the house and senate. Also working hard in national profiling. AMA-E15 is not labeled properly. Byron saw pump covering 3 different grades of E15. DO NOT use E15 in your motorcycles. Critter told of website, pure-gas.com that will show you where ethanol free pumps are. Doc has not heard anything about biodiesel. Shell gas is not recommended for some vehicles, consult with manufacturer guidelines. Sunoco, Citgo and Marathon are starting to get ethanol free.

TALLAHASSEE: Ride to the capital went well. If someone is paying the hotel for your group check your statements to make sure you weren't charged also. Hotel charged Doc's card and ABATE of Florida, Inc.

PRESIDENT'S REPORT

The last summer meeting has come and gone and now we look to the fall with the changing of the seasons and the migration of snowbirds coming to Florida. We will need to be even more aware of our surroundings when we ride. We are being hammered in the press about Florida having more accidents and deaths on motorcycles then any other state in the country. They never talk about the drivers only about us the riders. With next year being an election year we will be an easy target for our enemies to press for sanctions against motorcyclists.

We will make our wishes know in the Capitol at committee meeting this year and session in January. We have our vulnerable road bill and our safety money in this session. Then its election time for all the house part of the senate and a new Governor. It's time for changes in leadership in the Capitol for to long we have been treated like second class citizens and now we need to vote for people who support us.

I want to thank all the chapters for showing up at the past state meeting but we still have some miscommunication going back from the state meeting to chapter meetings. Make sure your notes are correct so the information gets out properly.

We are in this for a cause: to fight unjust Florida laws against motorcyclists. We have done this since we incorporated in 1981 (36 years). The phrase "a divided house will fall" is true. ABATE of Florida, Inc. speaks for the 900,000 licensed motorcyclists in Florida. That is a big voting bloc. We helped a House and Senate candidate narrowly win their seats (by 35 votes). It's all about working together. It's about freedom and protecting your way of living. The helmet law didn't get a hearing last year because our friends in the capital worked with us. If you want this lifestyle to continue you need to get involved. ABATE of Florida, Inc. is the last organization of freedom fighters in this state. When we speak to the legislators we are speaking for everyone. If you are tired of being an officer get new members and groom them for a BOD position. I'm willing to set the membership fee at \$15 to help build membership. Have been seeing chapters getting their names in the paper for supporting a charity. Charity begins at home. Thanked everyone who attended the Leadership seminars in July. The chapter Presidents learned about the situation with our ADD insurance directly from our AIL rep. Over \$250,000 has been paid out to ABATE of Florida, Inc. members and their families.

VICE PRESIDENT Darrin "Scribe" Brooks: If every chapter could at least sell 10 tickets to the Biker Bash we would be in good shape.

SECRETARY Shelly Johnston: There were a couple corrections to the minutes. Seminole County made motion to accept Secretary's minutes, 2nd by Freedom and approved.

TREASURER Patti Nasraliah: Bank accounts need to have \$500 balance. We now have credit card debt for the State meeting and Leadership seminars. The Hotline phone listed under expense is paid by Richard Lester

every 6 months. Beau (Vintage) asked that every chapter give \$100 so that the credit card balance could get paid off. He was told to bring it up again under new business. The rent on the State office is going up in October, it's time to leave it. There are things stored in there that chapters can use. We will get a storage unit to keep what we have to. Boots will get a list out of what we have, knows there are 2 safes from Brevard and a fire-proof cabinet. Chapters will have first choice and we will try to sell what isn't taken by chapters. We will need chapters to help move the stuff, chapter presidents will get an email when it's time to move. STATE OFFICE Ms. Boots: Has been receiving calls about the gun tickets asking if the mechanism on the rifle is steel or brass. It is steel. Second place is an over/under shotgun. Sell the tickets- all chapter Presidents and Treasurers got an email. She also has the handouts that were not picked from the Leadership Seminars.

MEMBERSHIP Laurie Hanley: Forest Chapter got highest % of growth and most new members for May. Vintage got highest % of growth for June and North Orlando got most new members.

PR/COMMUNICATIONS Sally Carroll: Good to see everyone here today. As previously requested she has rates for Full Throttle and Rebel Rider. Rebel rider does not publish any articles political in nature. She needs to be made an administrator on chapter Facebook pages. She needs to friend the chapter admin in order to get in. If you have a Facebook page, use Twitter, Linked In, Google or UTube for your chapter you do need to sign the social media SOP's. Several chapters still have not handed theirs in. They were available at the seminars and Boots has extra copies also.

WEBMASTER Dan "SIO MO" Henderson: All is fine. Contact Slo Mo if you need help with web designs.

SAFETY DIRECTOR Victor Piorkowski: If you have questions on motorcycle safety and awareness or how to get the program into the schools or how to get started and what you will need email, call or text him. Leave a message so he can get back to you.

PRODUCTS Steve Knee: No new shirts today, hopefully for next State meeting. Does have short sleeve life member shirts in medium and x-large. Also has a couple of "Bikers Lives Matter' shirts. Doc and Beau have received a lot of good comments on theirs. There is a new life member products form, prices have gone up a little...

LEGISLATIVE Darrin "Scribe" Brooks: Lake County finally did it-they boxed him in. We are halfway to another session. Campaign 2018: ABATE of Florida, Inc. members will be very educated on candidates and decisions. We want changes, we need to elect pro-motorcycle people. Share his emails with your members. Putnam now has an opponent, Jack Latvala. Richard Corcoran has opened an exploratory account so there is a possibility he may also run. The Democrats may be looking at John Morgan. Darrin will educate us on the

candidates but he will not come out in support of anyone yet so we do not alienate anyone. Contact him by email if you want to get his emails. Chapter presidents, vice presidents, newsletter, legislative trustees and delegates should be getting his emails already.

LOBBYIST Doc Reichenbach: Doc had meeting on Monday with the legislator who did the helmet bill last year. Since he is only allowed six bills he wants to do a bill that would pass rather than a bill that isn't going to be heard. He asked Doc if he would help him on an opioid bill. Doc said he couldn't speak for ABATE of Florida, Inc. but would personally say something. He also brought up the gang problem in Florida. Doc asked specifically what gangs. He said street gangs and other gangs. Don't be surprised if a gang bill is introduced. Doc told him since this is an election year there may not be any controversial bills as the legislators don't want to do bills that would make them unpopular. He told Doc he was surprised Doc didn't support the helmet law. Doc said he was surprised he didn't stand up for the people's rights. They agreed to disagree on that point. He did agree to speak to Governor Scott regarding the safety money. Charlie Stone (House) and Dennis Baxby (Senate) are sponsoring both the Stiffer Penalties Bill and the safety money. We have a lot of support for the safety money. It's the governor who keeps vetoing it. A lot of things ABATE of Florida, Inc. does is behind the scenes, such as no riding side by side or no more than 5 in a group which was stopped several years ago. Most bills are killed before they reach committee. We may have a problem in 2018 Clemens, who is anti-motorcyclist, will be the leader of the senate. Will be bill to get the safety funds and an amendment to put the money back in a trust fund so they cannot use it anymore. Let Doc or Darrin know what's going on locally. Committee meetings start next month. Question was raised if we were going to try to get a Purple Heart tag for motorcycles again. Doc will try to attach it on another bill. Another question about the red white and blue motorcycle specialty tag. ABATE of Florida does not get the money. It is divided between charities which represent possible injuries to motorcyclists. In return they agreed they would not support a helmet law.

LEGAL COUNCIL: Doc: we do not have an attorney sitting on the board. We do have one that will be handling things for the corporation.s.

NCOM: The convention will be in Mobile Alabama in 2018. It is close enough that you could go if you wanted to. You will see you it is run and what it's all about so in 2019 when we host it in Orlando we will know a little more. They have set up a committee for a seminar that will probably talk about helmets.

MRF & AMA: AMA is still working on the 15% ethanol issue. Do NOT put it in your motorcycle-it will eat it up. There are pumps with 40-60-80% ethanol out there-they are for flex fuel cars. MRF is also working on the 15% ethanol. They are also looking for sponsors for the national profiling bill. Doc has not been contacted by anyone who has been profiled.

TALLAHASSEE: The ride to the capital will be Monday February 12, 2018. The State meeting will be Sunday February 11. It will be cold. Last year only 80 people showed up. That makes us look bad when we have thousands of members. We voted to go. When asked who was going most of the delegates raised their hands. We need chapters to go, other bikers to go. We need a strong showing. We are locked and loaded when we go to the capital. We have facts to back us up. Discussion about motels and campgrounds near the staging area for the run. Doc will look for another motel when he goes to the capital again.

PRESIDENT'S REPORT

It's been a couple of weeks since the last state meeting but I want to thank Peace River for hosting the meeting. As usual they did a great job. This letter is only going to deal with a situation that came up today in the Florida legislature.

Today I received an update from the Florida legislature that will affect every MOTORCYCLIST IN THE STATE IF IT PASSES. It is House Bill 419 and will require every rider in the state to carry the exact same insurance as automobile. What that will mean is we will have to carry PIP. The insurance companies have never liked this because it could put us off our motorcycles and the cost could be atrocious. This is a call to arms check with the legislative officer to find out what committees this bill is going to and who are on the committees. You need to contact your legislators and tell them to vote no on this bill.

House Bill 2018 will put \$300,000 in Abate of Florida, Inc's hands for Motorcycle safety.

House Bill 117 and Senate Bill 116 both are our vulnerable road user bills.

Senate Bill 346 requires moped riders under the age of 21 to wear a helmet but the problem is they could place a amendment on it that would require all of us to wear a helmet.

It sounds like open season on all motorcyclists. Now is the time if you have never called you legislators and you want to remain free then call the abate legislative officer and then call your Senator and House member tell them vote NO on HB 419 and Senate Bill 346.

The next state meeting will be in Vero Beach we will really discuss these bills and the impact they could have on us. Until then Ride Safe and Free!!!

SB346 does not apply to persons riding within an enclosed cab or to any person over 21 years of age who is operating or riding upon a motorcycle powered by a motor with a displacement of 50 ccs or less or is rated not in excess of 2 brake HP and which is not capable of propelling such motorcycle at a speed greater than 30 MPH on level ground.

House Panel Backs Red Light Camera Repeal HB6001.

HB215and SB 504 relates to autocycles, which by definition have two wheels in front and one in back. This will change the definition of a motorcycle.

LOBBYIST Doc Reichenbach:
