There was a ladies tank, v neck, sport bike, reflective green with Motorcycle safety and awareness, short sleeve hang up and drive, a mechanics type shirt that was very nice. She will get with BOD and we will pick about 10 styles of shirts. Also a "Watch for Motorcyles" with phone saying hang up and drive". Send an email to Brandy what shirt you want and colors. Doc thanked Brandy for going overboard on getting all this together.

MASTERLINK VACANT: Patti Nasrallah, Acting Editor:

Has not been able to get Masterlink out. Critter will be the new Masterlink editor so we should have one soon.

LEGISLATIVE Darrin "Scribe" Brooks:

There will be new handouts at the seminar. Give the PR/COMM person know so they can submit to the newspaper. This is election year. You will see ads from groups like the League of Woman Voters where they have meet the candidate nights. Meet every candidate at tables, get every member of chapter to go. Dress like bikers, we will be noticed. Look for monthly events. If you know of any candidates that are motorcycle friendly or NOT motorcycle friendly let him or Doc know.

LOBBYIST Doc Reichenbach:

Doc read an article about a former Suncoast member who met with a candidate for senate. They are calling for restricted driving hours for motorcycles (in the evening and overnight) because that's when the most

motorcycle accidents "appear" to happen. They also want a helmet law for new endorsees. This would include motorcyclists from other states relocating here. Full Throttle used to give us a space in their magazine. Hopefully Magneto, our new PR/COMM can get us back in. magazine. We have been helmet-free 18 years on July 1. It has been stopped every year since. UF donates a lot of money to legislators regarding helmets, scooters and bikes. They (UF) have hired a diversity person. Their students riding mopeds without helmets are getting hurt and killed. Helmet bill was an amendment of the Safety bill. We want the texting bill to go again. It only failed by one vote. He believes every student should go thru a driver's education class. \$350 to take the motorcycle test. Motorcycle safety classes should be handled by motorcyclists. Our \$ 2.50 fee used to go to separate budget but now goes to general funds. An 80 year-old guy killed a motorcycle police officer who was responding to another officer's death. He turned down a plea and is fighting the ticket. The officer's mother wants justice. Doc is going to show her the old bill and try to get her to go to capital to testify.

LEGAL COUNCIL:

Doc: we do not have an attorney sitting on the board. We do have one that will be handling things for the corporations.

MRF:

We are again fighting the E15, we have a sponsor in the house: Lois Frankel.

AMA:

Still fighting E15. Sent Doc a ballot for AMA Hall of Fame.

NCOM-

Next year's conference is in Orlando May 9-12, 2019. We all voted to help with the conference. Gator Alley and Lake will be driving the vans. There will be a bike show-would we like to help? They also are planning to have a BBQ. Frenchie suggested a Gator night. Seminars on Leadership will show how different states do things. ABATE of Florida, Inc. will have a seminar on our Safety Program.

TALLAHASSEE:

The State meeting has been changed to Sunday April 14, 2019 and the ride to the capital is Monday 4/15. Last year we had we had 56 bikes, about 80 people. If we want these bills passed we need to show up.

OLD BUSINESS:

North Orlando is done. Their President, Woody, could not get his members to take a position on their board or help in any way. Doc has talked to the clubs and they said they would support our State Party. We had no problem when they came to Spooks. They had their own spot and their own security.

Election of new officers: Billy Bird took over meeting to conduct the election. The positions that were voted on were President and Treasurer. Voting was done by roll call of delegates and also paper ballot. Doc Reichenbach was voted to remain President. Deborah Hamby was elected to Treasurer. The financial committee was dissolved and a new committee formed with Darrin and Bill Bird as co-chairs. Talk to them if you want to help. We need to find ways to raise money since we don't have the campgrounds or Avon Park any more.

Lobbyist Proposal: We received only one bid for the Lobbyist and that was from James "Doc" Reichenbach. Discussion on lobbyist duties and reporting to delegates. Carol (Middleburg) suggested we not sign contract but rather wait to let the financial committee raise money. Doc said he calls the legislative officer all the time

with updates, his job is to get the bills through. Grizz made motion to have lobbyist give a report every month, motion was 2nd, majority opposed, motion failed. Critter said chapters should support State. Grizz made motion to accept the Lobbyist proposal, 2nd by Vintage and motion was approved.

NEW BUSINESS:

Proposals for hosting the State meetings in 2019 are due before or at the August 11 State meeting which is in Ocala at the Realtor Building and is hosted by State. Flyers are in the packets.

Doc said he truly believes we need a State party. Karen (Heart Attacks wife) has offered her property to us to use. It is in Bronson (Levy County). Doc asked Darrin to chair a committee to plan a State party. It could be a permanent place or be rotated around the state. Doc also said we need to cut back on chapters doing charities.

Brandy suggested we pass the hat for the wait staff.


Monica gave back all but \$20 back to State from 50/50.


