Bikers ride to Tallahassee in Support of motorcycle safety bill

Motorcycle deaths and injuries have been on the rise.

More than 100 bikers were at the Capitol Monday to advocate for legislation aimed at making the roads safer for motorcycle riders.

ABATE of Florida is the state's primary motorcycle rights organization, or "MRO," with about 20 local chapters across Florida. The group is essentially the advocacy voice for Florida's motorcycle community. ABATE stands for American Bikers Advocating Training and Education.

The organization's 29th "Rally to the Capitol" saw membership recognize motorcycle riders who have died during the past year and advocate for motorcycle safety legislation (HB 709, SB 838) currently working its way through the House and Senate.

The bills, sponsored by Sen. Jay Collins and Rep. Taylor Yarkosky, would require the Florida Department of Highway Safety and Motor Vehicles to contract with a nonprofit focused primarily on motorcycle safety and education.

The bill sets requirements for the nonprofit, namely that it be a Florida-based group that has been promoting motorcycle safety for at least 30 years and has a membership of at least 3,000 people. ABATE of Florida, with about 6,000 current members and a more than 40-year track record, would qualify for the contract under the proposed requirements.

The contracted nonprofit would administer an education program and would be funded by way of a \$2.50 fee that DHSMV already collects from Florida riders when they apply for a motorcycle license endorsement.

The fee, which ABATE of Florida advocated for, was intended to be used "exclusively" for motorcycle safety and education when it was put in place, but over the years the law has been changed to allow it to be used to fund "the general operations of (DHSMV)."

ABATE is universally respected in the motorcycle community — a rarity given the diversity of the community, which encompasses veterans' groups, current and former law enforcement, Christian groups, family groups, retiree groups, Harley owners groups, and many more.

The organization has received state funding in the past. The year that ABATE of Florida was charged with administering the program was the only year the state saw a decrease in motorcycle deaths and injuries.

But ABATE lost state funding in 2011 amid the Great Recession budget shortfall, when lawmakers modified the statute to allow the fee to be used for general operations at DHSMV. Motorcycle deaths and injuries have climbed in the years since.

The legislation under consideration this year is moving forward with bipartisan support. SB 838 cleared the Senate Transportation Committee with a unanimous vote two weeks ago; HB 709 advanced through the House Transportation & Modals Subcommittee last week, also with a unanimous vote.

However, the House bill was amended in committee to give DHSMV broad leeway in how the funding is used and would even allow the Department to keep the funding for itself. Proponents of the original bill say the committee substitute whiffs on the original intent — had DHSMV been providing adequate motorcycle safety education, they say, a shakeup wouldn't be needed.

HB 709 is now awaiting a hearing in the House Infrastructure & Tourism Appropriations Subcommittee. The Senate companion, which has not been altered, next goes before the Senate Appropriations Committee on Transportation, Tourism & Economic Development.

5. Safety Booth Presentations. Were discussed and stressed that anyone can setup the Presentation, but please document it and send pictures.

6. MSAP – Discussed the process of becoming certified and talked about having certification classes at the next Delegate Meeting. Lana offered to help with training. Estero – what kind of documentation do we need for MSAP? Forest – I have been an instructor and if you schedule a class let me know. We have an upcoming class if you want to join us. We have many people who might be able to join. SE – If you were certified 4 years are you still certified? Discussed issues with lapsed certifications.

7. We will be updating our Safety DVD.

LOBBYIST: Rich - The only reason we are where we are is because of ABATE. Doc has been nothing but helpful to me. Know who your Reps are for tomorrow. Address the staff in their office and thank them for supporting the "Motorcycle" bill. SB 838 or HB 709 is what will be addressing. Explained the Representatives and Senators that have helped with the advancement of this bill. Rich also discussed and explained the Insurance Tort reform just as an FYI. Russ read the HB 709 and explanations were given on the changes including the removal of the name of ABATE. This could be beneficial because the new qualification has guidelines that ABATE meets. Only 2-3 Non-Profits will meet these qualifications. *Big reminder that the DOT members will be fighting to keep this money in their budget, but do not have a Lobbyist right now. Big shout out to Sen. McClain in helping us get the bill heard in its 1st committee.

May is Motorcycle Awareness Month

Motorcycle Safety Awareness Month - May 2023

Motorcycle Awareness Month is observed in May and was instituted by the National Safety Council. Come summer, and the riding season begins in earnest. It's the perfect month to remind drivers and motorcyclists to take extra care — to respect and share the road. There exists a deep-seated prejudice against motorcyclists — reckless driving is one of them. Motorcycling is risky, they say. While that's true, safety when driving is a two-way street. Motorcyclists must, of course, practice safe driving habits. But it doesn't absolve everyone else on the road of their responsibilities. Everyone on the road is responsible for safety — passenger cars, trucks, pedestrians, and motorcyclists.

History of Motorcycle Safety Awareness Month

Each year, motorcycles in the U.S. travel almost 22 million miles. Unlike car drivers, motorcyclists don't have seat belts, airbags, or the relative safety of an enclosed vehicle. Besides helmets, nothing is protecting the riders should an accident happen. Motorcycle riders and their passengers are at a high risk of serious, sometimes critical injuries. That's usually the case if bikes collide with other vehicles.

Most motorcycle crashes happen when other drivers on the road can't see them. Drivers may be distracted or uncomfortable with two-wheelers on the road. Anxious motorists attempt to anticipate where a motorcyclist will go, and steer their cars accordingly. All these reasons compounded with nerves results in terrible driving decisions. For motorcyclists, the situation can become extremely unsafe. The National Highway Traffic Safety Administration (N.H.T.S.A.) reports that motorcyclists were 25 times more likely to die in a traffic crash than people in passenger cars.

Motorcyclists must protect themselves from potentially dangerous situations. But other drivers need to be equally cautious, too. It's imperative to respect a motorcycle's space and right of way. Remember to take care when following or passing one on the highway. Stay aware of each other's space. It's an excellent way to ensure safety, not only in May but the whole year through.

Motorcycle Safety Awareness Month May reminds all drivers to respect and share the road. The campaign also aims to educate riders on how to stay safe while riding and all the risks involved. Motorcycles account for just 3% of registered vehicles in the U.S., but they make up 14% of fatal crashes in a year.
