"The death of Patrick Lyoya

Today was a sad day in our state and country as the video of the shooting of Patrick Lyoya by a Grand Rapids Police officer was shown by the local authorities.

These incidents are tough to watch and stir up emotions and thoughts that can be difficult to process.

And as these police-involved shootings have led to peaceful protests, they have also sometimes led to violent demonstrations resulting in the loss of life and property. In the past, these were incidents that occurred elsewhere around the country, but this time, it hits close to home.

This incident will no doubt spark discussions amongst the prisoner population and staff. We urge all to be respectful of these discussions and find ways to communicate calmly and peacefully. And be mindful of the feelings and experiences that people have when talking about such topics.

Gov. Gretchen Whitmer offered the following words we wanted to share with you as well.

Patrick's father asked me to convey his hope that any demonstrations in his son's honor remain peaceful, and as Governor I share this view. We must come together and build a future where Black Michiganders are afforded equal rights, dignity, and safety in our communities. I will never stop fighting to make Michigan a more equitable and just state."

WHAT'S SO CRAZY, DISTURBING, AND JAW DROPPING IS THAT THIS MESSAGE CAME ON OUR JPAY SYSTEM FROM OUR WARDEN JEREMY HOWARD ABOUT A YOUNG BLACK MAN THAT ESCAPED TO THIS COUNTRY WITH HIS FAMILY TO PREVENT FROM BEING MURDERED IN HIS OWN. A PREJUDICE COP ENDED UP KILLING HIM FOR NO REASON! VERY HEARTBREAKING TO SAY THE LEAST, BUT MY CONCERN IS HOW MUCH OF A CROCK A SHIT IT IS THAT THE WARDEN OF THIS DEADLY BLACK MOLD EMBEDDED PRISON ALONG WITH THE GOVERNOR OF OUR STATE/PRISON ALL OF A SUDDEN GOT SO MUCH CARE AND CONCERN AND A HEART FOR HEARTFELT MATTERS OUTSIDE OF THEIR JOB DESCRIPTIONS/DUTIES WHEN THEY BOTH WERE MADE AWARE THAT ONE OF THE PRISONERS THAT THEIR RESPONSIBLE FOR IS LITERALLY DYING DUE TO HER BEING HIGHLY ALLERGIC TO THE MOLD IN WHICH THE PRISON'S OWN NURSES, DOCTOR'S AND SUPERVISORS KNOW AND AGREE THAT IF SHE IS NOT RELEASED FROM THIS PRISON, AND SOON, THAT SHE WILL SURELY DIE BECAUSE OF THIS ENVIRONMENT THAT WE ARE IN IS KILLING HER! WHICH ALSO MEANS THAT SHE IS NOT FREE NOR SAFE FROM THE MOLD BECAUSE THIS PRISON WAS BUILT ON SWAMP, MOLD EMBEDDED LAND, NOT TO MENTION, THIS PRISON WAS ALREADY CONDEMNED PRIOR TO US COMING HERE DUE TO BLACK MOLD, AN UNSTURDY, CONSTANTLY SINKING FOUNDATION, UNFIXABLE AND VERY COSTLY LAND. BECAUSE THERE IS MOLD THROUGHOUT EVERY BRICK USED TO BUILD THIS PLACE, OUR ROOMS, SHOWERS, LOUNGE, ETC, THAT IT IS LITERALLY, NO PLACE SAFE FOR HER THAT IS WITHOUT MOLD IN THIS FACILITY. THIS ENVIRONMENT IS KILLING HER SLOWLY AND UNTIL SHE IS FREE FROM "THIS ENVIRONMENT" NO MEDICINE EVER ADMINISTERED TO HER WILL WORK UNTIL SHE'S AWAY AND OUT OF THIS PLACE. THE MEDICINE/S THAT SHE'S ON AND ARE CONTINUOUSLY BEING PRESCRIBED, WHICH HAVE ALREADY KILLED OFF HER GOOD BACTERIA NEEDED TO HELP HER FIGHT, IS ONLY SUSTAINING HER FOR A MINUTE UNTIL HER BODY JUST SHUTS DOWN, CAUSE IF AND WHEN SHE GETS TAKEN OFF, SHE'D DIE INSTANTLY!!! WHAT KIND OF PERSON COULD DO THAT TO A HUMAN BEING KNOWINGLY AND NOT GO OVER AND BEYOND THE CALL OF DUTY TO HELP A PERSON IN THEIR OWN CARE/IN DIRE NEED OF MEDICAL CARE??? HOW SO SAD THAT THE WARDEN EXPECTS FOR EVERYONE TO FOLLOW HIS LEAGUE BY DENYING ANYTHING SHE NEEDS, ASK FOR, REQUIRED TO HAVE BY POLICIES OR MEDICALLY APPROVEN DETAILS, AND GRIEVANCES THAT SHE HAS WRITTEN ON MULTIPLE OCCASIONS ABOUT HER UNHAPPINESS AND URGENT CONCERNS OF THE WAY SHE'S BEING TREATED AS WELL AS HER INACCURATE DIAGNOSES, LACK OF PROPER HEALTHCARE, AND HER CONTINUOUS HEALTH DETERIORATION.
