

Contraindications:

Vibroacoustic Lounge and Sound Bath

CAUTIONS AND WARNINGS - Here are the absolute contraindications:

Acute thrombosis

Pregnancy

Cardiac pacemaker or other implanted devices (ex.cochlear implant, intrathecal device etc.) Any Electrical implants

Open wounds (including those related to surgery which may not yet have fully healed) Active bleeding Gabriel Ettenson, MSPT

Do not use sound healing if you suffer from epilepsy unless you have consulted your doctor to ensure you receive the right anti-epileptic medication and are in no danger of seizure from sound vibrations.

Not intended for any implanted heart pacemaker, stent or shunt.

The following people should consult their doctor before the first use of sound healing: • People with carotid stenosis (prior to application in the area of the carotid

artery/larynx) • People with cardiac pacemakers, artificial heart valves, or cardiac arrhythmias

- People with a stent
- People with a shunt
- People with a deep brain stimulation device (DBS) People with epilepsy
- Pregnant women

Treatment should not commence until three days after injury at the earliest for:
