#### **General Rules**

- 1. The Design Specialty Flower Show is open to all NGC members.
- 2. The *Handbook for Flower Shows* conforms to the Standards established by the NGC, Inc. The HB, 2017 Edition, with revisions in *The National Gardener* in the Member section of the NGC website, is the authority for all issues not covered by the schedule, which is the law of the show.
- 3. Advanced registration is required by September 11, 2021. Contact Chris Leskosky 570-459-0239.
- 4. Completed entry cards for all designs will be provided by Committee.
- 5. The Standard System of Awarding is listed in the 2017 *Handbook for Flower Shows*, Chapter 5 I. A. Page 39.
- 6. Entries will be received and placed on October 11, 2021, from 9-11 a.m.
- 7. Each Exhibitor is limited to one entry per class, but may enter multiple classes.
- 8. Judging will begin at 11:30 a.m. on Monday, October 11, 2021.
- 9. The Standard System of Judging will be used and the <u>decision of the Judges shall be final</u>. <u>Awards may be withheld if not merited</u>.
- 10. There must be an emphasis on plant\_material. No artificial plant material is allowed.
- 11. At the close of the show, the exhibitor is responsible for the removal of exhibit. The Committee is not responsible for such removal. Exhibits must be removed following the conclusion of the evening state board meeting.

### **Awards**

The NGC Standard System of Awarding is used in all Sections and Classes. Awards to be given in each class if merited. The Scale of Points is based on perfection (100 pts.)

1 first (blue ribbon) must score 90 or above

1 second (red ribbon) must score 85 or above

1 third (yellow ribbon) must score 80 or above

1 or more Honorable Mention (white ribbon) must score 75 or above

Judges will mark non-blue ribbon winners for 90+ recognition.

Three **Designer's Choice Awards** are eligible for Sections A, B, and C.

**Design Specialty Flower Show Achievement Award** is eligible for highest awarded exhibit in show. **GCFP Flower Show Staging Award** is eligible for the show.

**NGC Educational Top Exhibitor Award** 

Pa. Education and/or Conservation Silver Award

### **Design Rules**

- 1. Advance registration is required. If unable to attend, exhibitor must find a substitute.
- 2. Plant and non-plant material is permitted. No artificial plant, fruit or foliage may be used. Dried plant material may be used (or treated). Some plant material must be used in every exhibit.
- 3. Materials must be labeled on a 3x5 card by the exhibitor and included with the entry card.
- 4. Each entry is the work of the exhibitor. Exhibitor may only have one design in each class, but may exhibit in more than one class.
- 5. All designs will be **CREATIVE PETITE DESIGNS**. HB p.71-72 vi defines "creative."
- 6. Designer's Choice of all components.
- 7. Each exhibit will be staged on a 14" x 14" x 14" white corrugated box on a white covered table, Total height from floor to top of box is 44". Boxes will be in front of neutral colored walls. It is highly recommended to have a background panel and underlay to determine the parameters of your design.

## **Design Division I** "Dance the Night Away"

# **Section A.** <u>5 inch Petite Design</u>s- "Rock and Roll is Here to Stay" (not to exceed 5" in any dimension)

- Class 1. Born in the USA (Bruce Springsteen) 4 entries
- Class 2. Tumbling Dice (The Rolling Stones) 4 entries
- Class 3. Jailhouse Rock (Elvis Presley) 4 entries

# **Section B.** 8 inch Petite Designs- "I Love Rock and Roll" (not to exceed 8" in any dimension)

- Class 4. Twist and Shout (Beatles) 4 entries
- Class 5. Chain of Fools (Aretha Franklin) 4 entries
- Class 6. Great Balls of Fire (Jerry Lee Lewis) 4 entries

# **Section C**. <u>12 inch Petite Designs</u> "Rock-It Man" (not to exceed 12" in any dimension)

- Class 10. Rock Around the Clock (Bill Haley and the Comets) 4 entries
- Class 11 Splish Splash (Bobby Darin) 4 entries
- Class 12. Moondance (Van Morrison) 4 entries
- Class 13. Tiny Bubbles (Don Ho) 4 entries

### **Educational Rules**

- 1. Education exhibits may be the work of more than one individual or organization.
- 2. An exhibit must occupy a minimum of 6 square feet surface area.
- 3. Committee will provide white covered tables.
- 4. Exhibitor is encouraged to include plant material, Dried and/or treated dried material is allowed.
- 5. NO artificial plant material is permitted.
- 6. A 3x5 card must be used to identify any plant material in display.
- 7. The scale of points for Educational Exhibits is listed in the *Handbook for Flower Shows*, Chapter 14, page 130.
