## **RICHARD FEDER: Selected Cases**

*William Penn School Dist. v. Pennsylvania Dept. of Educ.*, No. 587 M.D. 2014, 2023 WL 1990723 (Pa. Commw. Ct. Feb. 7, 2023) (amicus representing constitutional law professors) (finding State school funding system unconstitutional) (citing amicus brief favorably).

*Farina v. Bank of New York*, No. 15-3679 (3d Cir., Sept. 28, 2021) (Court-appointed amicus). Adopting amicus's argument that federal courts should not abstain under *Colorado River* doctrine from challenges to mortgage foreclosures.

*Williams v. City of Philadelphia*, 188 A.3d 421 (Pa. 2018) (in-house counsel). Upholding City's sugar sweetened beverage tax against preemption challenge.

*Rufo v. Board of License & Inspection Review*, 192 A.3d 1113 (Pa. 2018). Upholding ordinance requiring real windows and doors on vacant buildings. Reversing both courts below.

*Leach v. Commonwealth*, 141 A.3d 426 (Pa. 2016) (co-counsel). Voiding statute that combined two unrelated subjects: theft of copper pipe; and standing to challenge firearms ordinances.

*Board of Revision of Taxes v. City of Philadelphia*, 4 A.3d 610 (Pa. 2010). Although City could not abolish Board of Revision of Taxes in its entirety, City could transfer the Board's property assessment function to a new Office of Property Assessment.

*Nutter v. Dougherty*, 938 A.2d 401 (Pa. 2007). City not preempted from adopting local campaign contribution limits.

*Jackson v. Hendrick*, 746 A.2d 574 (Pa. 2000). Reversing jurisdictional dismissal of City's challenge to contempt finding and \$2,000,000 fine.

*City of Philadelphia v. Clement & Muller*, 715 A.2d 397 (Pa. 1998). City not preempted from imposing business privilege tax on beer distributors.

*Blackwell v. City of Philadelphia*, 684 A.2d 1068 (Pa. 1996). Refusing to interfere with internal City Council personnel matter.

*National Rifle Association v. City*, 977 A.2d 78 (Pa. Commw. 2009). NRA lacks standing to challenge City ordinance that mandates reporting of lost or stolen weapons within 24 hours.

*Cohen v. Allen*, 744 A.2d 810 (Pa. Commw. 2000). Upholding amendment to School District Charter making terms of Board members coincident with that of Mayor.

*City of Philadelphia v. FOP, Lodge No. 5*, 723 A.2d 747 (Pa. Commw. 1999). Upholding, in part, City's right to make reduced payments to temporarily disabled uniformed personnel.

*Licensed Beverage Ass'n v. Board of Education*, 680 A.2d 1198 (Pa. Commw. 1996). City and School District not preempted from imposing liquor-by-the-drink tax.

*Lodge No. 5 of the FOP v. City of Philadelphia (Bergman)*, 677 A.2d 887 (Pa. Commw. 1996). Upholding City's right to assign Deputy Managing Director as Deputy Police Commissioner.

*1916 Delaware Tavern v. Zoning Board of Adjustment*, 657 A.2d 63 (Pa. Commw. 1995). City not preempted from enforcing prohibitions on dancing activity in liquor licensed establishments.
