Your monthly budget plan payment is calculated based off your previous years fuel consumption. To calculate your monthly budget plan payment, we multiply your previous years fuel consumption by an average price per gallon for the year. You are not locked-in to this rate. The price per gallon you will be charged for each delivery will be the prevailing market-rate on the day of your delivery. We do our best to provide you with as accurate information as possible; however we cannot be held liable should market conditions drastically change. At certain times throughout the year your account is reevaluated to ensure your budget plan stays on track. While you are on the Budget Plan, it is also your responsibility to monitor your account balance. In the event there is a unreasonably high balance on your account your deliveries may be held until the balance is brought down to an amount that is felt to be reasonable by Empire Fuel.

Automatic Deliveries will be made according to your usage. Our company monitors your fuel usage to the best of our abilities; however if you are low or out of fuel, please call the office for immediate delivery. We are not responsible for damages caused by lack of fuel. During the non-heating season deliveries will be less frequent. Our Budget Program begins on June 15th and ends on April 15th the following year. This program affords you the ability to mail-in monthly payments toward your fuel bill (or can be charged monthly to your debit/credit card on file). Any balances left at the end of the season must be paid by May 31st. Any accounts not at a zero balance will be unable to continue the budget program the following season. Any credits will be carried over into the new season and will not be refunded.

## TERMS AND CONDITIONS

- 1.) All Budget Payments are due by the 15th of each and every month while on the budget program.
- 2.) Your credit/debit card will be charged on or on the immediate business day after the 15th of each month.
- 3.) "Business Day" shall be defined as any day other than Saturday, Sunday, or Federal Holiday
- 4.) A credit/debit card is required to be kept on file even if you mail your payments in each month.
- 5.) Any automatic delivery paid via credit/debit card that we are unable to process will restrict your ability to receive any further deliveries until that balance is paid in full.
- 6.) If we refer collection of the balanace to our collection agency, you agree that you will be liable for reasonable attorney fees incurred plus interest and court costs.
- 7.) If you are found in default of payment, you agree to pay the principle balance in addition to any and all interest, late fees, attorney fees and court costs.
- 8.) You shall be considered in default if your balance is not paid within Thirty (30) days of the end of the budget plan term or file for bankruptcy.
- 9.) We are not responsible for any damages caused by a lack of oil due to the inability of delivering due to poor driveway conditions or if the fill location is inaccesible.
- 10.) Your driveway must be made accessible at the time of a delivery under the driver's discretion.
- 11.) During the Budget Plan you must be on automatic delivery and you understand that your price per gallon will be the prevailing market-rate on the day of your delivery. This rate will not be fixed or capped. The rate will be based on the market and will change with the market.
- 12.) On Automatic Delivery, you understand that your tank must be filled at each delivery. Any request for less than a full tank will void this agreement as we will not be able to accurately forecast future deliveries.
- 13.) Empire Fuel shall not be held liable for damages based on or caused by a failure to deliver fuel to a vacant or unattended premises (an unattended premises is defined as any dwelling which no adult occupant is present for (24) twenty-four consecutive hours). In each and every case, Empire Fuel has the right to cancel or to postpone any delivery without liability whatsoever.

14.) Both parties agree that this agreement and any other documents to be delivered in connection herein may be electronically signed and any electronic signatures appearing on this agreement are the same as handwritten signatures.

15.) Should you decide to terminate your budget plan prior to May 31st, you agree to bring your account to a zero balance at the time of your request.
