Blower motors and humidifiers, electronic air cleaners, any and all plumbing work. Riello Oil burners and power venter. Any Electronic Circuit boards or any control malfunction. Any issues directly related to the installation or use of Google Nest thermostats.

Terms and Conditions 2022-2023

- 1. We reserve the right to inspect the equipment covered before accepting this agreement and the right to charge for parts and labor within the first 30 days after acceptance.
- 2. This agreement is void if the buyer permits any person other than our employees to perform services to the equipment except as instructed by one of our technicians or if the customer is past due in payments due to Empire Fuel.
- 3. This agreement DOES NOT cover discontinued parts or labor of parts damaged by water, fire, accident, tampering or abuse, power failure, or an act of God.
- 4. This agreement is only valid to customers that purchase home heating fuel from Empire Fuel.
- 5. Our obligation to furnish parts is subject to their availability through normal sources of supply.
- 6. This agreement includes any repairs or replacement of parts specifically listed which are defective due to normal wear
- 7. This agreement does not include equipment failures from customer's lack of oil.
- 8. This agreement does not cover liability for injury or damage resulting from defects of the operation or non-operation of customers oil burner or its appurtenance or any other equipment nor does it cover liability from loss or damage resulting from delay or failure to perform hereunder due wholly or partially to labor disturbances, fire, lack of material, governmental regulation, or any cause beyond our control.
- 9. Effective date of this agreement, for exsisting service plan customers, shall be the date of receipt by the company of customer's signed application and full payment.
- 10. This agreement does not permit billing, all services are to be collected on a COD basis (unless other arrangements have been made).
- 11. This agreement contains the entire agreement of the parties thereof and there are no promises, terms and conditions, or obligations other than printed herein and may be terminated by either party at any time in writing. Prices are subject to change at any time without notice. (no monies shall be refunded).
- 12. Empire Fuel is not liable for damage to unoccupied dwelling or building.
- 13. This agreement is non-transferable and non-refundable after 3 days of the effect of the agreement.
