

## INSTRUCTIONS FOR POOL REGISTRATION 2026

1. You must be in good financial standing. All assessments and other financial obligations—including late fees, fines, attorney fees, and similar charges—must be paid by the first of each month.
2. Complete and return all required forms:
  - 2026 Pool Registration Form (mandatory)
  - Parental Release Form (for children ages 10–17)
  - Babysitter Authorization Form (if applicable)

### 3. Key Fobs:

Once your paperwork is received, each unit will be issued one key fob. If a key fob is lost or damaged, a \$25 replacement fee will apply. All key fobs must be returned at the end of the season; otherwise, a \$25 fee will be charged.

### 4. Guest Passes:

Guest passes may be purchased when you pick up your key fob and wristband. If you need additional passes during the season, email the pool manager at [maplehillpoolmanager@gmail.com](mailto:maplehillpoolmanager@gmail.com) to request them and arrange pickup. The cost is \$15 for a book of five guest passes.

PLEASE NOTE: Guest passes will not be sold at the pool by the lifeguards.

I hereby authorize the above-named child(ren) to enter the swimming pool operated by the Maple Hill Community Association during normal hours of operation. I understand that the Association will have a Red Cross certified lifeguard on duty during all hours of operation and authorize the lifeguard to undertake the following tasks on behalf of any child of mine who is injured at the pool:

- Immediately administer emergency first aid assistance to the child, which may include, but is not limited to, the administration of CPR.
- To immediately summon the nearest rescue unit by telephone.
- To immediately contact me at the above home or work telephone number as soon as possible after the administration of emergency first aid and the summoning of rescue units.

I understand that personnel of Maple Hill Community Association will administer no medications and that the lifeguard's authority is limited to stabilizing an injured person until the arrival of the rescue unit.

Use of the pool by any of the above-named children without my presence is undertaken subject to the above procedures. Each of the above children will be directed by me to follow specific instructions of the lifeguard and to follow such general rules and regulations regarding pool use as may be enacted from time to time.

So long as the above procedures are followed, I hereby release the Maple Hill Community Association, its board members, officers, servants, agents, and the employees from any and all liability, of every kind, character, and description, arising out of or connected with use of the swimming pool of the Maple Hill Community Association by any of the above named children.

This release and consent shall remain in effect until revoked in a writing signed by me and shall apply to all incidents which may occur prior to receipt of a written revocation by the Association.
