Docu+ Signs MOU with Nafalia Corporation of Malaysia at PREVUE Event in Seoul



Seoul, South Korea — November 10, 2025 — Documentary media venture **Docu+** has signed a **Memorandum of Understanding (MOU)** with **Nafalia Corporation**, a leading Malaysian creative company, during the **PREVUE: Broadcasting Content Pre-Production Project Business Matching Event**, held at the **Fairmont Ambassador Hotel** in Seoul.
