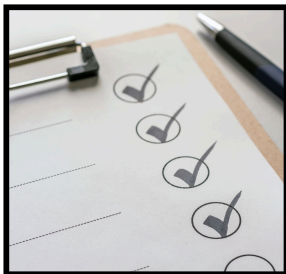

DOT Drug & Alcohol Testing Compliance Checklist

Purpose: Ensure compliance with DOT/FMCSA drug and alcohol testing regulations to maintain safety, avoid fines (up to \$16,864 per violation), and pass audits. Partner with D&G Lab Services for seamless testing and support

1.) Drug & Alcohol Testing Program
