# American Mosquito Control Association's Updated *Best Practices for Integrated Mosquito Management*

In 2021, the American Mosquito Control Association (AMCA) published an update to their *Best Practices for Integrated Mosquito Management* manual that includes new information on managing *Culex* species and reducing arbovirus transmission.

The Centers for Disease Control and Prevention (CDC) funded the update to help AMCA create publicly available resources dedicated to addressing the growing threat posed by vector-borne disease and train the nation's vector control workforce.

The 2021 update of the AMCA's Best Practices for Integrated Mosquito Management includes an additional focus on managing populations of Culex mosquitoes and reducing the transmission of arboviruses such as West Nile virus and St. Louis encephalitis virus.


